VII. **Public Comment:**

Mifflin County Regional Police Chief Andre French wanted to inform the Commissioners that he is the Coordinator of the Police Traffic Safety Grant. Chief French thanked the Commissioners for supporting this project. The project is about traffic safety and reducing motor vehicles accidents, reducing injuries and deaths on our county roads.

Mr. Ralph Aitkins ask if the election recount would cost the county any additional money. Solicitor Snook responded and said no additional county dollars would be spend on the recount. County employees are doing the recount without any additional hours.

Jim Zubler from DLI gave an update on the Local Economic Revitalization Tax Assistance Act (LERTA). The Borough of Lewistown passed this in August of 2020. LERTA is a tax abatement program. The Act is to incentivize redevelopment of aging or deteriorating commercial properties. Lewistown Borough also passed a companion ordinance for residential properties. The abatement is for ten years. The residential side is on a sliding scale decreasing by 10% each year. The Commercial side is 100% abatement for the first five years. Property owner must be current with taxes and up to code. This is exclusively for Lewistown Borough. Mifflin County School District also passed the ordinance. There

is one project that is currently pending and LERTA is very important to the project. It is the rehabilitation of the former Buchanon School.

VIII. New Business:

A. Proclamation – June 6-10, 2022 is Child Welfare Professionals Appreciation Week

Proclamation Recognizing the Staff of Mifflin County Children and Youth

WHEREAS, the week of June 6-10, 2022 has been proclaimed as Child Welfare Professionals Appreciation Week by Governor Wolf, recognizing the efforts of child welfare professionals serving the children of Pennsylvania; and

WHEREAS, every day in Mifflin County, local children are at risk of child abuse and neglect or have been removed from their homes due to such abuse and neglect; and

WHEREAS, we, the Commissioners of Mifflin County recognize the risks and the need to protect the children in the Commonwealth; and

WHEREAS, the challenging task of investigating child abuse, providing services to families, assessing safety, and providing services to ensure that the children of Mifflin County are provided with nurturance, family connections, support as they transition into adulthood, and services that allow a child to remain safely in their home or return home as expeditiously as possible falls to the child welfare professionals of Mifflin County's child welfare system; and

WHEREAS, the work of child welfare professionals may require them to enter into situations in which their personal safety may be put at risk, such as the COVID pandemic, throughout which caseworkers continued to conduct investigations and work with families in their homes, at great risk to their own health; and

WHEREAS, child welfare professionals work in difficult and emotional situations with children who have been victimized by physical abuse, sexual abuse, neglect, and other forms of maltreatment; and

WHEREAS, the professionals of Children and Youth must develop great skill in working with families who are in crisis situations, struggling with mental health challenges, suffering from drug and alcohol afflictions, poverty, and other difficult issues; and

WHEREAS, the professionals of Children and Youth must develop substantial knowledge and skills surrounding the rights of families, the laws surrounding child welfare, and the legal processes governing the system; and

WHEREAS, every year, child welfare professionals are injured or killed in their pursuit to protect children across the United States; and

WHEREAS, innumerable injuries and deaths of children in Mifflin County have been averted due to the efforts of Children and Youth; therefore, in special recognition of the efforts of Children and Youth serving the children of Mifflin County, We, the Commissioners of Mifflin County, do hereby issue this Proclamation recognizing the staff of Children and Youth for their dedicated efforts in protection the children of Mifflin County.
