VII. Public Comment:

Commissioner Kodish wanted to thank all of the poll workers and election staff in their fine work on Election Day. They received numbers of 9,100 voters in Mifflin County, which is 34%.

Mr. Griffith said this is for the two free standing planters in front of the building, but since we don't need them right now we are deleting them.

Mr. Wolfkiel said these are the agreements with our providers for the pretrial grant. Commissioner Postal said that two of them run to June 30, 2022 and the other one runs to September 29, 2022. Nick said they should run through to the same date, and he was going to check with Lisa.

Motion was made by Commissioner Postal to accept these after we clarify the terms of the agreement. Commissioner Kodish seconded the motion. The motion was unanimously approved.

H. Project Modification request for the Mifflin County Intermediate Punishment Grant – changes to the types of materials and supplies

Mr. Wolfkiel said that minor changes were made with the new building (annex). We took out the window, ring doorbell and ring subscription because there is another security system Phil explained. The grant will now be used towards a new monitor.

Motion was made by Commissioner Postal to be approved. Commissioner Kodish seconded the motion. The motion was unanimously approved.

Mr. Griffith spoke and said this is cleaning services for these 3 buildings. It will be outsourced to NuVisions Center. Commissioner Postal asked if this will save the county money, and Lonnie said yes, about \$18,000.00.

Motion was made by Commissioner Postal to be approved. Commissioner Kodish seconded the motion. The motion was unanimously approved.

Motion was made by Commissioner Postal to be approved. Commissioner Kodish seconded the motion. The motion was unanimously approved.

L. Public Defender Services Agreement with Robert Ferguson, Esquire, Lewistown, PA, for the period November 1, 2021 through December 31, 2021 - \$3,000.00 per month

Motion was made by Commissioner Postal to be approved. Commissioner Kodish seconded the motion. The motion was unanimously approved.

Motion was made by Commissioner Postal to be approved. Commissioner Kodish seconded the motion. The motion was unanimously approved.

P. Consideration of compensation rate for the Mifflin County Municipal Authority Board Members

Commissioner Kodish spoke and said "At the beginning of the formation of the MCMA, the primary goal was to create as minimal disruption as possible to the then-current MABL. MCMA was framed to be a change of form instead of substance, and the goal was to keep the "status quo" as much as possible with all of the workings and operations of our local water authority.

In light of that, I make a motion to have compensation set for the MCMA that mirrors the prior MABL board member compensation of \$150 per member per monthly meeting, with the Chairman and the Secretary being paid an additional \$50 each — so \$200 total per monthly meeting — on account of the additional work those two (2) officer positions entail.

Again, this would mirror the prior MABL compensation. I would also, as a part of that, move that the members be entitled to such pay for two (2) prior meetings in addition to those moving forward – the meeting held at the end of September (which was the first "orientation" meeting to familiarize them with how the MCMA would work moving forward), as well as their first official meeting in October."
