E. Resolution No. 29 of 2020 extending the Keystone Opportunity Expansion Zone (KOEZ) for the Mifflin County Industrial Development Corporation

## RESOLUTION #29 of 2020

A RESOLUTION EXTENDING THE TERM OF EXEMPTIONS, DEDUCTIONS, ABATEMENTS AND CREDITS FOR REAL PROPERTY, EARNED INCOME TAX, NET PROFITS, MERCANTILE AND BUSINESS PRIVILEGE TAXES WITHIN A SPECIFIC GEOGRAPHIC AREA IN <u>GRANVILLE TOWNSHIP, MIFFLIN COUNTY</u> DESIGNATED AS A KEYSTONE OPPORTUNITY EXPANSION ZONE ("KOEZ"), IN ORDER TO FOSTER ECONOMIC OPPORTUNITIES, STIMULATE INDUSTRIAL, COMMERCIAL, AND RESIDENTIAL IMPROVEMENTS AND PREVENT PHYSICAL AND INFRASTRUCTURE DETERIORATION WITHIN AREAS OF THE <u>MIFFLIN COUNTY</u>, COMMONWEALTH OF PENNSYLVANIA, UPON CERTAIN TERMS AND CONDITIONS.

WHEREAS, Mifflin County recognizes the need to encourage investment in a defined geographical area of Mifflin County, bounded as set forth in <u>Attachment 'A'</u> (the "Extended Parcel"), that is experiencing distress characterized by one or more of the following: high unemployment, low investment of new capital, blighted conditions, underutilized, obsolete or abandoned industrial commercial and residential structures, deteriorated tax base; and

WHEREAS, the Extended Parcel consists of an unoccupied portion (s) of a KOEZ within Mifflin County which is KOEZ expires on December 31, 2020; and

WHEREAS the Keystone Opportunity Zone, Keystone Opportunity Expansion Zone and Keystone Opportunity Improvement Zone Act (Act of October 6, 1998, P.L. 705, No. 92), as amended, hereinafter referred to as the "Act," authorizes political subdivisions to apply to the Pennsylvania Department of Community and Economic Development (DCED) for an extension of the term of the applicable benefits within the respective unoccupied portion(s) of the KOEZ granting exemptions, deductions, abatements or credits from all local taxes identified in the Act; and

WHEREAS, approval of extending the term of the benefits for the Extended Parcel as provided in the Act will result in improving the economic, physical, and social conditions within the subject KOEZ by stimulating existing businesses employment, creating new employment and diminishing blight; and

WHEREAS, it is expected that increased private and public-sector investors will reverse the disinvestment and conditions of blight of the Extended Parcel by the termination date of the extended term.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Mifflin County, that effective as of this date \_\_\_\_\_\_\_\_, 2020 contingent only upon DCED's approval of the application for the proposed term of the Extended Parcel of the existing KOEZ, the term of the Extended Parcel is extended for a period of 10 years from the date of occupancy of the Extended Parcel or expiration of the KOEZ, whichever occurs first as determined by the Department.

FURTHER RESOLVED, that the following provisions shall apply to the extended term once the Extended Parcel is occupied:

1.

Real Property Tax on the Proposed KOEZ is 100% exempt in accordance with the provisions and limitations hereinafter set forth in accordance

with the Act, such exemption to begin on January 1, 2021 and to terminate December 31, 2030.

2.	The following shall be exempt, in accordance with the provisions and limitations set forth within the Act, relative to the Extended Parcel:
	a. Business gross receipts tax for operations conducted by a Qualified Business within the Extended Parcel.
	b. Business privilege tax.
	c. Tax on the earned income received by a resident of the Extended Parcel.
	d. Tax on the net profits of a Qualified Business attributable to business activity conducted within the expansion zone.
	e. Mercantile license tax attributable to business activity by a Qualified Business conducted within the Extended Parcel.
	f. Tax on occupancy or use within the Extended Parcel.
	g. Sales and use tax (for purchases used and consumed by a Qualified Business within the Extended Parcel).
	Benefits to begin on January 1, 2021 and terminate on December 31, 2030.
3.	The provisions of the Act not herein enumerated, shall, nevertheless, be incorporated as part of this resolution by reference.
4.	This resolution shall be effective upon execution, conditioned upon the approval of the application by DCED.

*Mr.* Felice mentioned that the list of parcels has been corrected to remove a parcel that was previously listed in error.

*Commissioner Postal reiterated the taxes are paid until these parcels are improved. Mr. Felice confirmed that was correct.* 

Motion was made by Commissioner Postal to approve Resolution No. 29 of 2020 extending the Keystone Opportunity Expansion Zone (KOEZ) for the Mifflin County Industrial Development Corporation. Commissioner Kodish seconded the motion. The motion was unanimously approved. F. Addendum to the Mifflin County Correctional Facility and Oasis Management System, Inc., Commissary Contract

Mr. Garver stated this is an addendum to the original contract. When this contract began, the Mifflin County Correctional Facility was one of the pilot programs. Because the system is now up and running, Oasis has agreed to give MCCF an additional 0.5% on commissions. This contract is renewed every five years.

Motion was made by Commissioner Postal to approve the addendum to the Mifflin County Correctional Facility and Oasis Management System, Inc., Commissary Contract. Commissioner Kodish seconded the motion. The motion was unanimously approved.

G. Ratification and letter of understanding between the County of Mifflin, acting by and through the Mifflin County Correctional Facility, and Geisinger-Lewistown Hospital for health care services to inmates for calendar year 2020

*Mr.* Garver discussed this is something needed for the State. It's an understanding that Geisinger-Lewistown Hospital will accept inmates from the Mifflin County Correctional Facility in emergency cases and that the Correctional Facility will pay the Act 22 rates.

Motion was made by Commissioner Kodish to approve the ratification and letter of understanding between the County of Mifflin, acting by and through the Mifflin County Correctional Facility, and Geisinger-Lewistown Hospital for health care services to inmates for calendar year 2020. Commissioner Postal seconded the motion. The motion was unanimously approved.

H. Sub-recipient Agreement between Mifflin County and Armagh Township for the FFY 2018 Community Development Block Grant Funds

Mr. Lettiere explained this is for the demolition of 73 North Main Street in Milroy, Armagh Township funded by County CDBG funds. The agreement is between Armagh Township Supervisors and the Mifflin County Commissioners. The CDBG amount is \$51,000 for demolition and delivery. Armagh Township invested \$5,000 for legal fees. They were issued a conservatorship by the Court of Common Pleas for the demolition. The environmental review has been completed. The bids should occur in April and the bid awarded in June. Demolition will then take place in either July or August.

Motion was made by Commissioner Postal to approve the sub-recipient agreement between Mifflin County and Armagh Township for the FFY 2018 Community Development Block Grant Funds. Commissioner Kodish seconded the motion. The motion was unanimously approved.

*I.* Change order for the CDBG project, 15 & 17 Henrietta Street Demolition and Wall Reconstruction

Mr. Marks stated this project was contracted in December 2019 for Granville Township on Henrietta Street. Two homes are being demolished and a wall adjoining with the next building is being reconstructed. When the project began, it was known that the engineer would have to assess the remaining wall to determine if any changes needed to be made because some of the items were unforeseen. This change order is for some additional framing the engineer deemed necessary to the existing wall. The contract is with the County, but Granville Township will be paying the entire change order in the amount of \$3,922. The same contractor will be performing the work.

*Commissioner Postal pointed out that Granville Township is paying the additional* \$3,922 *out of their funds and Armagh Township is paying* \$5,000 *for the previous agenda* 

item. He feels it's important that municipalities have some of their funds in these programs.

Motion was made by Commissioner Postal to approve the change order for the CDBG project 15 & 17 Henrietta Street Demolition and Wall Reconstruction. Commissioner Kodish seconded the motion. The motion was unanimously approved.

J. Resolution No. 30 of 2020 adopting the Mifflin County Hazard Mitigation Plan

Resolution No. 30 of 2020 Mifflin County, Pennsylvania

**WHEREAS**, the municipalities of Mifflin County, Pennsylvania, are most vulnerable to natural and human-caused hazards which may result in loss of life and property, economic hardship, and threats to public health and safety, and

**WHEREAS**, Section 322 of the Disaster Mitigation Act of 2000 (DMA 2000) requires state and local governments to develop and submit for approval to the President a mitigation plan that outlines processes for identifying their respective natural hazards, risks, and vulnerabilities, and

**WHEREAS**, Mifflin County acknowledges the requirement of Section 322 of DMA 2000 to have an approved Hazard Mitigation Plan as a prerequisite to receiving post-disaster Hazard Mitigation Grant Program funds, and

**WHEREAS**, the Mifflin County Hazard Mitigation Plan has been developed by the Mifflin County Planning and Development Department and the Mifflin County Department of Public Safety in cooperation with the Hazard Mitigation Advisory Committee, local municipal officials, and the citizens of Mifflin County, and

**WHEREAS**, a public involvement process consistent with the requirements of DMA 2000 was conducted to develop the Mifflin County Hazard Mitigation Plan, and

**WHEREAS**, the Mifflin County Hazard Mitigation Plan recommends mitigation activities that will reduce losses to life and property affected by both natural and human-caused hazards that face the County and its municipal governments,

**NOW THEREFORE BE IT RESOLVED** by the governing body for the County of Mifflin that:

- The Mifflin County Hazard Mitigation Plan is hereby adopted as the official Hazard Mitigation Plan of the County, and
- The respective officials and agencies identified in the implementation strategy of the Mifflin County Hazard Mitigation Plan are hereby directed to implement the recommended activities assigned to them.

*Mr.* Colussy stated the Federal Disaster Mitigation Act of 2000 requires counties to update their hazard mitigation plan at least every five years. Over the previous two years, the Mifflin County Planning Office and the Public Safety Office have been working to update that plan. The plan had been sent to PEMA and FEMA for review at the end of 2019. The Planning Department received a letter from FEMA on January 28, 2020 indicating the plan was approved pending adoption. He's asking that the Commissioners approve this Resolution and officially adopt the plan on behalf of the County. He noted all of the municipalities in the county will also need to adopt this plan. Once the county and at least one other municipality adopts the plan via Resolution, the plan is considered approved, which will reenact our ability to receive post mitigation disaster dollars in case of any disaster.

Motion was made by Commissioner Postal to approve Resolution No. 30 of 2020 adopting the Mifflin County Hazard Mitigation Plan. Commissioner Kodish seconded the motion.
