## VII. Public Comment:

None to report.

Public Safety Director Phil Lucas stated Mifflin County currently has two confirmed cases of COVID-19. The Department of Health doesn't notify as to where the patients are located. As far as we know, they are not hospitalized, but are at home being treated. Currently, supplies are being disbursed to first responders. Geisinger Lewistown Hospital has received supplies from the strategic national stockpile so they can increase the amount of personal protective equipment (PPE) for staff at the hospital treating their patients. They have set up a tent outside of the hospital so they can isolate those people who they feel are at greater risk for being positive for respiratory problems or associated with the COVID-19 virus. They are working to protect the patients in the facility. Over the next week or two, we'll be working with Geisinger Lewistown Hospital and the Department of Health to make arrangements that if we would see a significant increase in the number of positive patients in our community, we can be moving those at lower risk away from the hospital. This allows us to focus on providing treatment to those at greatest risk for being stricken with COVID-19 at the hospital. Regionally, we are working on distribution of PPE for first responders and we're seeing supplies from the strategic national stockpile for nursing homes across the state. We don't know what nursing home or when they will be receiving the PPE, but we believe the first group of nursing homes will be by the end of this week.

Currently, Mifflin County has been added to the statewide stay at home order by the Governor. This order reinforces the best practice of social distancing. The purpose is to minimize the interactions people have with each other. This limits trips and encourages people to go out for life-sustaining items only. It doesn't say you can't travel or pick up food, but you should do it only when absolutely necessary.

Commissioner Postal added we've had calls interpreting this as a curfew, but it is not an 8:00 p.m. curfew. He read a quote from the Governor's Release as follows, "Staying at home doesn't mean making a daily stop at the grocery store because you need to get out of the house. Staying at home means you stay at home."

Public Safety Director Phil Lucas agreed and added there is no curfew or restriction on travel at this point. He mentioned trips should be made out of necessity and should not include an entire family. As far as ventilators, statewide and nationwide, all elective surgeries have been canceled in order to maximize the bed capacity of the healthcare institution. Currently, we are at the point of using 12% of available ventilators at Geisinger Lewistown Hospital. Regionally and across the state, we're using 32% of available ventilators. Those most affected are those with respiratory problems and they need additional support in breathing to get them through the treatment cycle. In speaking with Geisinger Lewistown Hospital, they have made arrangements to use alternative devices to support breathing. He feels our region is in a good position at this point.

Commissioner Kodish thanked Roger Herto from MCTV for being here to film the meeting. He also thanked the County MIS department who went the extra mile to set up the Webex meeting this morning.

#### Resolution No. 34 of 2020

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF MIFFLIN COUNTY, PENNSYLVANIA,

# AUTHORIZING THE IMMEDIATE IMPLEMENTATION OF CERTAIN POLICIES AND PROCEDURES TO COMPLY WITH THE EMERGENCY DIRECTIVES OF PENNSYLVANIA GOVERNOR TOM WOLF AND THE PENNSYLVANIA DEPARTMENT OF HEALTH.

WHEREAS, On March 6, 2020 Pennsylvania Governor Tom Wolf declared an

Emergency Disaster for the Commonwealth of Pennsylvania;

WHERAS, Mifflin County passed a Proclamation of Disaster Emergency on

March 19, 2020;

WHEREAS, subsequently to the aforesaid Declaration, Governor Tom Wolf, on March 16, 2020 and March 19, 2020 ordered and directed more expansive prohibition of certain business operations and social activities within Commonwealth of Pennsylvania as well as subsequent directives issued by the Pennsylvania Secretary of Health, Rachel Levine, to address health and safety concerns regarding COVID-19 (Coronavirus);

WHEREAS, Section 509 of the County Code grants and authorizes to the MIFFLIN COUNTY BOARD OF COMMISSIONERS the executive and administrative powers to secure the health, safety and welfare of the citizens of Mifflin County;

BE IT RESOLVED, in accordance with the authority conferred by law, and in order to be in compliance with its practices and procedures consistent with the directives of Governor Tom Wolf and the Pennsylvania Department of Health, the Mifflin County Board of Commissioners does hereby implement the following policy and procedures:

1. Public Meetings. Any and all public meetings shall be done in a manner consistent with the Order and Directives of Governor Tom Wolf and/or by the Pennsylvania Secretary of Health, Rachel Levine, as in place at the time of this resolution or as otherwise lawfully instituted during the duration of the aforesaid declared Emergency Disaster for the Commonwealth of Pennsylvania;

2. Weekly Meetings. All meetings shall be held in compliance with Social Distancing Rules and Regulations as directed by Pennsylvania Department of Health (hereinafter "SDRR") and for the safety and welfare of Board Members and the public generally, the public is hereby given notice that Board Members and other necessary participants are hereby approved and encouraged to participate by electronic means. The aforesaid compliance to SDRR shall apply to any location where a meeting is scheduled to be held (hereinafter "Meeting Room") whether it occurs as scheduled prior hereto for every First, Third, and Fifth Thursday at 9 o'clock a.m. in the Commissioners Conference Room in the Courthouse, 20 N. Wayne St., Lewistown, PA or at a different location to comply with the aforesaid Emergency Orders and Directives; **3.** Meeting Room Occupancy. No more than ten (10) person(s) are permitted in the Meeting Room at any given time. Upon reaching the maximum capacity of ten (10) persons (which shall include the Board of Commissioners and its staff), no further access shall be permitted until the number of person(s) is reduced and entry of other person(s) shall be limited to the amount that vacate the Meeting Room in order that at no point in time maximum capacity is exceeded, unless an emergency requires further admittance. The Board may further limit the meeting room occupancy to the extent that may be necessary to comply with SDRR for the use of any temporary meeting location;

4. PUBLIC PARTICIPATION. Public participation to all Meetings shall be available by the use of WEBEX or similar solution. Information regarding the use of WEBEX or similar solution shall be posted on the Mifflin County Webpage. In the event it is not possible for a member of the public to utilize WEBEX or a similar solution, such a public member must contact the Mifflin County Chief Clerk in advance of a scheduled meeting with sufficient time to accommodate their attendance with compliance with SDRR to be accomplished by the use of telephone or other electronic participation;

5. Any person(s), business or other entity desiring to provide or present documents of any kind or other physical exhibits at a meeting must contact the Mifflin County Chief Clerk in advance with sufficient time to accommodate the presentation and/or if necessary their physical attendance but such presenter must at all-time remain in compliance with SDRR.

This Resolution shall be effective immediately and shall remain in effect until Governor Tom Wolf and/or Pennsylvania Secretary of Health rescinds the directives upon which the Resolution relies.

RESOLVED AND ADOPTED by the Board of Commissioners of and for Mifflin County, Pennsylvania, in lawful session fully assembled, this  $2^{nd}$  day of April, 2020.
