# A. Mike Hannon - TriCounty Drug and Alcohol Update

Mr. Hannon stated that the TriCounty Drug and Alcohol Abuse Commission covers Huntingdon, Mifflin and Juniata Counties with a main office in Lewistown. He thanked the Commissioners for the opportunity to come and make a presentation to bring awareness to the topic of substance abuse. He discussed many different aspects of addiction including the affect it has on family and friends, different organizations in place to aid in treatment, programs available for criminal drug offenders, the use of Narcan by first responders, the impact of different government funding and the drug takeback program.

- G. 3 Year Prison HVAC Service Agreement with NRG Building Services, Harrisburg, PA
  - September 1, 2018 through August 31, 2019 \$12,735.00
  - September 1, 2019 through August 31, 2020 \$12,735.00
  - September 1, 2020 through August 31, 2021 \$13,120.00

Mr. Griffith spoke on behalf of Warden Garver. This agreement is for the Correctional Facility and involves the controls aspect of the HVAC system. This service agreement will involve monthly calibration and servicing of the controls. This system has not been functioning adequately for the size of the building, so a separate system is now being installed in Jack Miller's office. This should alleviate the problem and allow more supply to the Correctional Facility.

Motion was made by Commissioner Postal to approve the 3 Year Prison HVAC Service Agreement with NRG Building Services, Harrisburg, PA. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

#### ORDINANCE NO. 1-2018

# AN ORDINANCE OF THE MIFFLIN COUNTY COMMISSIONERS, MIFFLIN COUNTY

PENNSYLVANIA, AUTHORIZING THE EXECUTION AND ENTRY INTO
INTERGOVERNMENTAL COOPERATION AGREEMENT BETWEEN THE BOROUGH OF
LEWISTOWN, MIFFLIN COUNTY, PENNSYLVANIA AND THE COUNTY COMMISSIONERS
OF MIFFLIN COUNTY, IN RELATION TO THE BOROUGH OF LEWISTOWN'S COMMUNITY
DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM ADMINISTRATION IN ACCORDANCE
WITH THE PENNSYLVANIA INTERGOVERNMENTAL COOPERATION LAW AND
CONTAINING REPEALER AND SAVINGS AND EFFECTIVE DATE PROVISIONS.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, AND IT IS HEREBY ORDAINED AND ENACTED, by the Mifflin County Commissioners, Mifflin County Pennsylvania, incorporating the aforesaid recitals as an integral part hereof, as follows:

<u>SECTION ONE: Intergovernmental Cooperation Agreements for Administration</u>

of Community Development Block Grant (CDBG) Funds: This Ordinance is ordained

and enacted pursuant to the provisions of The County Code, Act of August 9, 1955 P.L. 323, Act No. 130, 16 P.S. § 101 et seq, as amended and the Pennsylvania Intergovernmental Cooperation Law, as amended, 53 Pa.C.S.A. §2301 et seq., and otherwise per law).

SECTION TWO: Approval of the Cooperation Agreement between the County of Mifflin, Pennsylvania and the Borough of Lewistown, as regards to the Administration of Community <u>Development Block Grant (CDBG) Funds.</u> The Mifflin County Commissioners hereby approves the form and content of the Cooperation Agreement including Addendum-A relating to work assignments, by and between Mifflin County and the Borough of Lewistown for fiscal year 2016, and subsequent years thereafter as long as the County is required to administer the Borough of Lewistown's CDBG funds, as directed by the Pennsylvania Department of Community and Economic Development (PA-DCED) or successor agency, all parties which are political subdivisions and local government units of the Commonwealth of Pennsylvania, as defined by the Pennsylvania Intergovernmental Cooperation Law, as amended, and which Agreements are proposed to be made and executed by the said County and the Borough of Lewistown (collectively the "Parties" to the Agreement). The Cooperation Agreement and Addendum-A by and between the County of Mifflin, PA and the Borough of Lewistown for fiscal year 2016 and subsequent years thereafter, as long as the County is required to administer the said CDBG funds as directed by the Pennsylvania Department of Community and Economic Development (PA-DCED), or successor agency, is incorporated herein and made a part hereof by reference to the Ordinance enacted by the aforementioned political subdivisions and governmental units, designated as Schedule I. in the individual Ordinances.

<u>SECTION THREE:</u> Summary of Cooperation Agreements between the County of Mifflin, PA and the Borough of Lewistown for fiscal year 2016 and subsequent years thereafter, as long as the County is required to administer the Township's CDBG funds as directed by the Pennsylvania Department of Community and Economic Development (PA-DCED) or successor agency.

As required by §2307 (53 Pa.C.S.A. §2307) of the said Pennsylvania Intergovernmental Cooperation Law, as amended, the summary and substance of the Agreement, is as follows:

(a) The amount of money/grant funds to be disbursed for the benefit by and between Mifflin County and the Borough of Lewistown for fiscal year 2016 and subsequent years thereafter is set forth in the Agreement referenced and incorporated by Section 2, it being noted that the required hearings for citizen input to formulate community development plans and to address needs have been conducted and that the County has reviewed and

- approved the plans and proposed activities and has prepared the 2016 and 2017 application for funding to the PA Department of Community and Economic Development (PA DCED).
- (b) The Agreement, including Addendum-A relating to work assignments, sets forth the Scope of Services and the respective responsibilities of the parties, the time of performance, the budget, payments, notices and representatives, special conditions, general conditions, administrative requirements, relocation, real property acquisition and one-for-one housing replacement, personnel and participant conditions, environmental conditions, termination and modification, severability and paragraph noting that the Agreement is the entire agreement between the parties including Addendum-A.
- (c) The Agreement provides for an annual review by the Lewistown Borough Council and the County of outstanding plans and activities, as well as all potential future plans, so as to aid in the proper, efficient and satisfactory administration of said CDBG funds and projects.
- (d) The Agreement is as otherwise adopted by this Ordinance.

<u>SECTION FOUR</u>: <u>Execution of the Agreement</u>. The Chairman of the Mifflin County Commissioners, or in his absence, the Vice Chairperson of the Board of County Commissioners are hereby authorized and directed to execute and attest to the Agreement and counterparts thereof on behalf of Mifflin County. This authority and direction to execute the Agreements shall be authorized and carried out even if changes (and/or even if the more detailed or modified work assignments are agreed to by the parties), are made after the enactment of this Ordinance <u>provided that</u>, the Agreement is substantially in the form approved hereby and that such changes are editorial in nature and do not affect the meaning, intent, substance or effect of the Agreements as approved by this Ordinance.

<u>SECTION FIVE: Severability.</u> If any sentence, clause or section or any part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance.

It is hereby declared as the intent of the Mifflin County Commissioners that this Ordinance would have been adopted if such unconstitutional, illegal and invalid sentence, clause, section or part thereof had not been included therein.

SECTION SIX: Repealer and Savings. Otherwise, any Ordinance or part of any Ordinance or Resolution or part of any Resolution or Motion or part of any Motion conflicting with the provisions of this Ordinance is hereby repealed insofar as the same affects this Ordinance or is inconsistent with this Ordinance; otherwise, those provisions of Ordinances, Resolutions or Motions not hereby repealed or amended and not conflicting or not inconsistent herewith are confirmed.

**SECTION SEVEN:** Effective Date. This Ordinance shall take effect five (5) days after adoption.

**ORDAINED AND ENACTED** by the Mifflin County Commissioners, Mifflin County, Pennsylvania in public session assembled, this 2nd day of August 2018.

Mr. Lettiere discussed that the County took over administering the Community Development Block Grant (CDBG) funding for Brown Township, Derry Township, Granville Township and Lewistown Borough in 2015. At that time, the County was required to enter into a cooperation agreement with each municipality regarding the administration of funding. Since that time, the County has entered agreements with the remaining municipalities in Mifflin County. Lewistown Borough chose to have their cooperation agreement written for one year. This has been somewhat problematic since we don't anticipate any changes necessary in the near future regarding the DCED's position relative to the County administering their grant funds. Therefore, this Ordinance authorizes the entry of Lewistown Borough Council and the Mifflin County Commissioners in regard to the attached cooperation agreement. The Ordinance is a requirement under the Intergovernmental Cooperation Law. The Ordinance has been drafted with the approval of Solicitor Steve Snook. The agreement was executed by Lewistown Borough Council on July 9, 2018. The agreement spells out the contractual obligations for each party regarding the administration of CDBG funds. The difference between the agreement in 2015 and the agreement now is that it will be for year 2016

and every subsequent year thereafter. This agreement will not need to be redone as long as DCED continues to require the County to administer the funds.

Motion was made by Commissioner Postal to adopt Ordinance No. 1 of 2018. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

I. Cooperation Agreement between Mifflin County and Lewistown Borough for the Fiscal Year 2016 Community Development Block Grant Program Administration and Beyond

Motion was made by Commissioner Dunkle to approve the cooperation agreement between Mifflin County and Lewistown Borough for the Fiscal Year 2016 CDBG Program Administration and Beyond. Commissioner Postal seconded the motion. The motion was unanimously approved.

#### J. Personnel:

Motion was made by Commissioner Dunkle to accept the above personnel items. Commissioner Postal seconded the motion. The motion was unanimously approved.

Chairman Kodish then reminded all individuals expecting children that the Keystone Scholars Program is now in effect in Mifflin County. It provides a \$100 investment by the State for your child.
