G. Setting the Fees, Per Bills, for Elected Tax Collectors

H. Generator and Transfer Switch Maintenance with G.R. Sponaugle, Harrisburg, PA for the period March 1, 2021 through February 29, 2024 - \$8,147.00 per year

Mr. Griffith explained that this contract has to do with the back-up generator and back up switches for the Courthouse, 911 Center, Correctional Facility and four Tower Sites. This will be similar to our previous agreement with G.R. Sponaugle but with no increase per year and an additional tower site added.

Motion was made by Commissioner Postal to approve the generator and transfer switch maintenance with G.R. Sponaugle, Harrisburg, PA for the period March 1, 2021 through February 29, 2024 - \$8,147.00 per year. Commissioner Kodish seconded the motion. The motion was unanimously approved.

I. Resolution No. 2021 – 2 Authorizing an Application for the COVID-19 Hospitality Industry Recovery Program Grant Funds through the PA Department of Community and Economic Development

# RESOLUTION NO. 2021 - 2 OF THE MIFFLIN COUNTY BOARD OF COMMISSIONERS AUTHORIZING AN APPLICATION FOR THE COVID-19 HOSPITALITY INDUSTRY RECOVERY PROGRAM GRANT FUNDS THROUGH THE PA DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT

Be it RESOLVED, that the Mifflin County Board of Commissioners requests a COVID-19 Hospitality Industry Recovery Program Grant of \$522,576 from the Department of Community and Economic Development to be used for COVID-19 pandemic relief.

Be it FURTHER RESOLVED, that the Mifflin County Board of Commissioners does hereby designate the Chairman of the Board of Mifflin County Commissioners as the official to execute all documents and agreements between Mifflin County and the Department of Community and Economic Development to facilitate and assist in obtaining the requested grant.

Motion was made by Commissioner Postal to approve Resolution No. 2021 – 2 Authorizing an Application for the COVID-19 Hospitality Industry Recovery Program Grant Funds through the PA Department of Community and Economic Development. Commissioner Kodish seconded the motion. The motion was unanimously approved.

J. Grant Agreement with DCED for COVID-19 Hospitality Industry Relief Program Grant Funds

Mr. Colussy explained that the Planning Department is working on an application/contract for the COVID-19 Hospitality Industry Relief Program (CHIRP). There have been multiple news releases sent out by the State regarding this. This was approved by the State in Act 1 of 2021. The information for application became available last Wednesday, February 10, 2021 and the application was due last Thursday, February 11, 2021. Our application was processed and we had the contract by last Friday, February 12, 2021. This is important funding intended for hospitality businesses including but not limited to lodging and restaurants. Final details are being worked out at this time. The Planning Department has already received several phone calls regarding this funding. Generally speaking, this will be very similar to the County Relief Block Grant Funds received through the CARES Act.

Commissioner Postal added that this must be acted upon very quickly. Mifflin County is set to receive \$522,576.00 that can then be distributed to hospitality industry businesses.

Motion was made by Commissioner Postal to approve the grant agreement with DCED for COVID-19 County Relief Block Grant funds. Commissioner Kodish seconded the motion. The motion was unanimously approved.

K. Project Modification Request for the RASA/VOJO Grant

Ms. Glick explained that this PMR will move funds from the supplies budget to the salaries budget to help in the interim between employees.

Motion was made by Commissioner Postal to approve the Project Modification Request for the Victims of Crime Act Grant changing staff name. Commissioner Kodish seconded the motion. The motion was unanimously approved.

L. Award Notification for the VOCA Grant for the period October 1, 2020 through September 30, 2023 - \$189,063.00

Ms. Glick indicated this is the annual award for the VOCA funding received from the Pennsylvania Commission on Crime and Delinquency (PCCD). It is retroactive back to October 2020. PCCD has been working remotely and are a little behind.

Motion was made by Commissioner Kodish to approve the award notification for the VOCA Grant for the period October 1, 2020 through September 30, 2023 - \$189,063.00. Commissioner Postal seconded the motion. The motion was unanimously approved.

M. E-Recording Agreement with Simplifile, LC, Provo, UT to Provide Electronic Recording in the Register & Recorder's Office

Ms. Stringer explained that this will allow the office to record more documents on the computer rather than handling the documents in person. This will help cut down on potential exposure to COVID-19. This agreement will be at no charge to the county. Any fees charged by Simplifile will be paid by the client. This agreement will go on indefinitely. This will be a convenient option for anyone wanting to record documents from their home or business.

Commissioner Postal suggested this information be reviewed by our MIS department prior to implementation.

Motion was made by Commissioner Postal to approve the E-Recording Agreement with Simplifile, LC, Provo, UT to Provide Electronic Recording in the Register & Recorder's Office. Commissioner Kodish seconded the motion. The motion was unanimously approved.
