VII. Public Comment:

Craig Bubb, Executive Director of the Municipal Authority of the Borough of Lewistown (MABL) provided an update regarding the formation of a county-wide water authority. Various proposals have been reviewed by attorneys for both the MABL and Lewistown Borough. A memorandum of understanding (MOU) was drafted and presented at a special meeting held by Lewistown Borough. At that time, Lewistown Borough chose not to approve the MOU. MABL held a special meeting yesterday (September 2, 2020) and their Board approved the MOU. Lewistown Borough has scheduled another special meeting this evening to act on the MOU and Mr. Bubb is hopeful it will be approved. The MOU will end litigation, allow the Water Authority to act autonomously and will give the County an opportunity to potentially expand the purpose of the Water Authority. One of the terms of the MOU is that the Board will be expanded to 11 members with representation from all eight member municipalities. Mr. Bubb thanked the Commissioners for their support throughout this process.

Mike Fisher, SEDA-COG introduced Jamie Shrawder who will be Mifflin County's new point of contact at SEDA-COG. He also discussed a recommendation that all individuals or entities receiving Community Development Relief Grant funds will need to sign a sub-recipient agreement with Mifflin County.

Ms. Shrawder also spoke briefly about the Community Development Relief Grants and reiterated that any individual/business receiving funds will need to sign a sub-recipient agreement. She presented the Commissioners with a basic agreement that is based on the contract received from the PA Department of Community and Economic Development (DCED). Until DCED issues something in writing changing their contract, SEDA-COG will make sure we're covered under all conditions listed in their current contract. This agreement should be reviewed by the County Solicitor to determine if any changes need to be made.

Mr. Colussy stated that in the first round of Community Development Relief Grant applications received, 23 small businesses and 9 non-profits applied for funds in the amount of roughly \$400,000.00. These applications are currently being reviewed.

Mr. Fisher discussed that no other county he has been working with has not yet given out any funds. Mifflin County is on par with all other counties working with SEDA-COG. He

also stated the Mifflin County and MCIDC staff has done an excellent job getting this program together.

Commissioner Postal then mentioned that the 2020 census is still underway and individuals can report via telephone or the internet. He encouraged residents to cooperate with census field workers. Commissioner Kodish stressed that there will be Census workers out and about visiting homes of those who did not respond to the survey that was mailed to them.

Ms. Fisher discussed this is a coronavirus emergency supplemental relief grant used to purchase decontamination spray units for the Courthouse and Mifflin County Correctional Facility. Additionally, there are some devices to help with Zoom accounts and Wi-Fi access for essential employees.
