H. Memorandum of Understanding Agreement with the Borough of Lewistown for the 22 Ridge Road Demolition CDBG Project using Act 152 funds

CDBG Administrator Chastity Fultz explained this is for demolition costs of the property which has been vacant since 2004. It was demolished for a total of \$66,867.00. Lewistown Borough is requesting reimbursement in the amount of \$23,557.00. This was actually approved previously so this is just to go ahead and sign the memorandum of understanding and allow for the repayment.

No CDBG funds were used for this project. This is the third project in Lewistown Borough and the seventh done since 2019. Funds are still available for municipalities that need money to assist with demolition of blighted projects.

I. Bids for the Phase II Walnut Street Sidewalks CDBG Project

Housing Rehab Specialist Doug Marks stated this is a rebid for the project due to rejected bids. The project is for sidewalks on one side of Walnut Street and removal of trees on the opposite side.
