The Board of Mifflin County Commissioners met for their Regular Meeting on Thursday, May 30, 2019 at 9:00 a.m. In attendance were Commissioners Kevin Kodish, Stephen Dunkle and Robert Postal, Jr; Solicitor Stephen Snook, BMZ Law and Chief Clerk Cathy Romig.

VIII. New Business:

A. Request for exoneration of 2019 county portion per capita taxes:

• Wayne Township Tax Collector Mary Ellen Reed – 40

Motion was made by Commissioner Dunkle to approve the request for exoneration. Commissioner Postal seconded the motion. The motion was unanimously approved.

B. Offer for Parcel No. 15,02-0117L-,001 located in Decatur Township that is currently in repository for unsold properties - \$50.00

Motion was made by Commissioner Dunkle to approve the offer for Parcel No. 15,02-0117L-,001 in Decatur Township for \$50.00. Commissioner Postal seconded the motion. The motion was unanimously approved.

C. Water Management Service Agreement with Rochester Midland Corporation for the Courthouse and Jail for the period June 1, 2019 through May 31, 2020 - \$3,200.00

Mr. Griffith mentioned this is for the water treatment for the chillers and spray on top of the Courthouse roof. We were able to negotiate a decrease on this contract for this year. Last year's contract was \$3,700.00 and this year it's \$3,200.00. He recommends we renew this service agreement.

Motion was made by Commissioner Postal to approve the Water Management Service Agreement with Rochester Midland Corporation. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

D. Program Modification Request for the Mifflin County Reentry Strategic Plan Grant to extend the grant three months with a new end date of September 30, 2019

Ms. Stalnaker mentioned that PCCD awarded Mifflin County a \$19,000 grant to look at data surrounding prisoner reentry. There have been some reentry meetings and data has been collected. PCCD offers no-cost, three to six month extensions on the grants. We're requesting three months in order to provide a better analysis of the information.

Motion was made by Commissioner Postal to approve the Project Modification Request for the Mifflin County Reentry Strategic Plan Grant to extend the grant to September 30, 2019. Chairman Kodish stepped from chair to second the motion. The motion was unanimously approved.

- E. 2018 Community Development Block Grant (CDBG) Contract No. C000071567
 - Federal Funding Accountability and Transparency Act Sub-Recipient Data Sheet
 - Delegation of Signing Authority Form
 - Community Development Block Grant Program Contract \$666,245.00 Contract period April 16, 2019 through April 15, 2023

Mr. Lettiere stated that the 2018 CDBG Contract has been received for Mifflin County, Brown, Derry and Granville Townships and the Borough of Lewistown. In addition to the contract, there are two forms that are required to be submitted. One is the Federal Funding Accountability and Transparency Act Sub-Recipient Data Sheet and the other is the Delegation of Signing Authority Form, which delegates Mr. Lettiere as the signing authority for the individual invoices that are paid out of the program. The contract period is April 16, 2019 through April 15, 2023. All projects and funds must be expended by April 15, 2022. This is a four year contract, with three years to expend and complete the projects and one year to close out. This has been provided to Solicitor Snook and Mr. Baker for review and they did not object to this item going on the agenda today.

This dollar amount is roughly a 10% increase from last year.

Motion was made by Commissioner Dunkle to approve the 2018 CDBG Contract No. C000071567. Commissioner Postal seconded the motion. The motion was unanimously approved.

F. Memorandum of Understanding with Brown Township regarding the Brown Township Streetscape Project

Mr. Gomes discussed that there were some wording changes to this memorandum to make sure the County is not responsible for maintenance of any of the trees. Brown Township will approve this at their meeting next week.

Motion was made by Commissioner Dunkle to approve the Memorandum of Understanding with Brown Township regarding the Brown Township Streetscape Project. Commissioner Postal seconded the motion. The motion was unanimously approved.

- G. Award bid for the Mifflin County Correctional Facility Roof Replacement Project:
 - *Midstate Roofing & Coating, Belleville, PA \$495,000.00*
 - J.M. Young & Sons, Inc., Belleville, PA \$397,000.00
 - David M. Maines & Associates, Lewistown, PA \$397,462.00

Mr. Griffith explained that this is the alternate bid, which allows a time extension. He recommends awarding the bid to J.M. Young & Sons, Inc. for \$397,000.00. This is a total roof replacement for the Correctional Facility. When the roof was put on in 2000, it had a 10-year warranty. This bid contains a 20-year warranty. The replacement will be completed this summer.

Motion was made by Commissioner Dunkle to award the bid for the Mifflin County Correctional Facility Roof Replacement Project to J.M. Young & Sons, Inc., Belleville - \$397,000.00. Commissioner Postal seconded the motion. The motion was unanimously approved.

Motion was made by Commissioner Postal to accept the above personnel items. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

Commissioner Dunkle had a public comment he wanted to make. He congratulated Chairman Kodish and Commissioner Postal on their victories in the Spring Primary election. He stated they would be the Commissioners for the next four years along with former Commissioner Mark Sunderland. He stated he called Mark Sunderland to congratulate him on his victory, and he wanted to read a letter from Mr. Sunderland that he gave to the current Board of Commissioners dated May 2, 2019. It reads as follows,

"To Whom It May Concern, Voters of Mifflin County. As the election draws near, I have made a few commitments to myself as well as others. I am 100% committed to the two

community libraries in McVeytown and Allensville. I feel these two libraries fill a void left when they were closed at an earlier date. I will continue to fund the two libraries at the same rate currently set by the present Board of Commissioners. My other commitment to myself, to my family, as well as others, is that if elected to the position of Commissioner, I will serve only one term. I will not seek another term. Sincerely, Mark A. Sunderland dated May 2, 2019."

Commissioner Dunkle asked that the letter be included in the proceedings today.
