The meeting was called to order at 9:06 a.m. by Chairman Kodish.

VII. Public Comment:

Mr. Romej, Derry Township: I have a question about some rumors of upcoming expenses for the County. One is because of the jail and the other one is the Capital Murder trial. The total of those two was \$700,000.00 which had an impact on property taxes. So, can anybody clear up these items?

Chairman Kodish: I can tell you that we are going to award a contract today for PREA for the jail for the extensive cameras to redo the whole system. The amount we approve today we hope to lower by removing some cameras. As far as the Capital Murder trial, we are going to have a Bench Trial, the only expense we are going to be able to lower is for jurors, lodging and meals for an out-of-town jury. The time to pay the attorney is when they select the jurors, so we won't have those expenses. All of the expenses we have to date, they continue to build. The same counsel is involved since it is a Capital Murder Case. Unfortunately because it went as far as it did before the change was made, we still have all those expenses we have paid and are going to incur.

Mr. Romej: Is the \$700,000.00 correct?

Chairman Kodish: We hope it will come in under that. I think we are up to \$200,000.00 now.

Commissioner Dunkle: Are you talking both murder trial and prison for a total? That could potentially be low. I want to make one thing clear, in anticipation of what we had to do at the prison and in anticipation of the Capital Murder Trial, we built those costs into the budget for this year. So, I don't think those two things will be factored into next year's budget so, I do not foresee and increase in next year's budget, based upon those things.

Mr. Harpster: This grant runs through the Probation Department. We are asking for the money to be transferred from the task end of it to the Assessment end of it with no change in funding.

Motion was made by Commissioner Postal to approve the Project Modification Request for the Pre-trial Drug and Alcohol grant. Seconded by Commissioner Dunkle. The motion was unanimously approved.

G. Resolutions Numbers 9 through 25 of 2017 to change the check signatures on various county accounts

Chairman Kodish: This is due to New Commissioner Postal and Deputy Treasurer Kochenderfer. The signature cards had to be redone.

Motion was made by Commissioner Dunkle to approve Resolutions Numbers 9 through 25 of 2017. Seconded by Commissioner Postal. The motion was unanimously approved.

H. Ordinance No. 2 of 2017 authorizing of non-electoral debt by the issuance of general obligation bonds

Mr. Muscatello: We have been the County's bonding director since 1999. We have refinanced the bonds four or five times already. We were here in October and talked

about refinancing the bonds. We decided that we would refinance the bonds in March, sometimes things work and somethings don't. We are now in a good financial situation to do this. Last week we had a conference call with Standard & Poors for the credit rating of the County. Once we get that information back, we can refinance the 2012 Bonds. You will be saving about \$140,000.00, a one time savings. We don't extend the debt and we don't increase the amount. Whatever you budgeted will show a savings of \$140,000.00. We are looking at a bond issue of approximately \$7,495,000.00, subject to interest rate changes when the bonds are sold. The County should receive approximately \$150,000.00. I am pretty sure we are going to do better than the 150. 150 is the absolute minimum after costs. We will know once we receive the rating. You have to pay Standard & Poors even if you do not sell the bonds.

Mr. Garin: We are the County's Bond Counsel. We believe we have served in this role since about 1999. We placed the Debt Ordinance in front of you from the State law that controls borrowing for Counties. Commissioners will vote today on everything in the Ordinance including limits so we can proceed with the Rating Process, market the bonds and receive cost savings, roughly about \$142,000.00. So long as that can be accomplished, the bonds can be sold. Closing process will occur about thirty days after the Bond sale.

Chairman Kodish: I think the key operative in this is that this does not extend the terms of the Bonds. Ending dates are going to be the same with a savings of at least \$142,000.00. The move is made to get the savings off our Bond payment. This does not extend the terms.

Commissioner Dunkle: What was our County rating when we refinanced the bonds last year?

Mr. Muscatello: I think it was A-. I am hoping to get you upgraded.

Motion was made by Commissioner Postal to approve Ordinance No.2 of 2017. Seconded by Commissioner Dunkle. The motion was unanimously approved.

Commissioner Dunkle: Our two primary sources of debt are when the new prison was built and when the Courthouse was expanded. We make payments on these every year. And the Annex purchase.

I. Telemental Health Services agreement with InSight Telepsychiatry, LLC, Marlton, New Jersey, to provide mental health care services for inmates at the Mifflin County Correctional Facility for a one year period effective July 1, 2017

Chairman Kodish: UCBH provides these services currently, but informed us that they could no longer provide these services. We are going through PIMCC part of CCAP, they were able to get an agreement for us to provide those necessary services, if we need them.

Motion was made by Commissioner Dunkle to approve the Telemental Health Services agreement. Seconded by Commissioner Postal. The motion was unanimously approved.

Chairman Kodish: Hopefully, it will be significantly lower. There were cameras where we are not going to need them now. There were quite a number eliminated. We opened bids from five companies and X-Pert from State College was the low bidder by a long shot.

Commissioner Postal: This is one of these mandated things – Correct?

Chairman Kodish: Yes, for PREA.

Commissioner Dunkle: And the contract allows for those modifications?

Deputy Warden Weaver: Yes.

Commissioner Postal: These are to be completed by mid-July?

Deputy Warden Weaver: Yes.
