WHEREAS, Mifflin County is committed to working with Central Pennsylvania Food Bank and its partner agencies in educating people about the role and importance of food banks in addressing hunger and raising awareness of the need to devote more resources and attention to hunger issues; and

WHEREAS, the coronavirus pandemic has had devastating health and economic impacts across the country, and it is projected that the food insecurity rate in Mifflin County will rise to 13.7% in the wake of the pandemic; and

WHEREAS, the month of September has been designated "Hunger Action Month" in order to bring attention to food insecurity in our communities and to engage the public in action – including volunteer shifts, social media shares, and donations – to end hunger one helping at a time; and

WHEREAS, food banks across the country, including Central Pennsylvania Food Bank and its partner agencies—will host numerous events throughout the month of September to bring awareness and help end hunger in their local community;

NOW, THEREFORE, We, the Mifflin County Commissioners, do hereby recognize September 2022, as **HUNGER ACTION MONTH** in Mifflin County and we call this observance to the attention of our citizens.

The public is encouraged to get involved by donating, participating, and advocating. Ms. D'Isabella also shared there will be an upcoming White House conference on hunger on September 28, 2022. She also expressed thanks to local partners who support those in need.

Mr. Postal asked if any of the total amounts changed in any of the four modifications requested today or if it is just a reallocation of the line items in each grant. Ms. Stalnaker confirmed it is just a reallocation.
