The demolition program is ran by funds collected from the filing of mortgages with the register and recorders and office. We have a substantial amount of funds right now and we are willing to help various municipalities and nonprofits with demolition of any unsafe structures. This is the 5<sup>th</sup> project with these funds. Properties 613, 615, and 609 and 611 were all destroyed in a fire. At the beginning of this year Derry Township declared the properties unsafe. Commissioner Postal asked if the properties are sold, will there be a reimbursement to the county? If they are sold, yes we will get half.
