F. Resolution No 32 of 2022 consolidating Mifflin County Revolving Loan Fund Programs **RESOLUTION 2022-32**

Consolidating Mifflin County Revolving Loan Fund Programs

WHEREAS, Mifflin County Commissioners support programs to assist businesses, municipalities, and others in order to create jobs and economic growth; and

WHEREAS, in 1997, Mifflin County established the Mifflin County Revolving Loan Fund with a grant from the Pennsylvania's Department of Community and Economic Development; and

WHEREAS, in 2006, Mifflin County established a separate and second revolving loan fund program with a grant from the U.S. Department of Agriculture; and

WHEREAS, because the two original grants that established the two programs also established different terms and conditions for lending from the separate revolving loan funds: and

WHEREAS, the different terms and conditions currently lead to unnecessary confusion to borrowers and an unnecessary burden for the administration of the separate programs.

NOW THEREFORE, BE IT RESOLVED, in order to ease the administrative burden and increase the use of the revolving loan funds for purposes of job creation and economic growth, the two separate Revolving Loan Fund accounts will be consolidated into one account known as "The Mifflin County Revolving Loan Fund"; and

Furthermore, The Mifflin County Commissioners and advisors will, from time to time, evaluate the terms and conditions and change the guidelines in order to better accomplish the objectives of job creation and economic growth.
