#### VII. Public Comment:

Commissioner Dunkle commented that the Library Board had indicated they would have two members present at every Commissioners' Meeting, but there were no Library Board members in attendance at today's meeting. Commissioner Dunkle reiterated that he will continue to shed light on the inappropriate means by which the library branches were closed. At the last meeting, he focused on the method used – a notice posted on the front door stating that the branch was closed until further notice. Today, he will focus on where the decision was made to close the libraries. The Library Board chose to close the McVeytown branch in Belleville. The people of McVeytown that wanted to go to the meeting affecting their library had to travel to Belleville. He detailed the many available locations that could have held the meeting in McVeytown. He mentioned that it would have been fair to have such a meeting in the community in which the library was located, particularly when the library receives almost \$250,000 in taxpayer funding from Mifflin County. Even more troubling to him was that McVeytown had partnered with the library for 51 years to provide library services to their community. He feels the Library should have reached out to the elected officials and the community to discuss closing the branch. If they had done so, there may have been a way to continue library services. He posed a question to the audience and asked how Mifflin County Library would feel if the State discontinued the appropriation they had been providing and posted a notice on the front door saying that the Library was closed until further notice. Commissioner Dunkle said he would fight against such an action because he believes right is right and wrong is wrong. He said that if such a thing happened, he felt that Molly Kinney would protest, gather support against the decision, meet with the County Commissioners and meet with the State officials to get their assistance. If the Library were closed in this manner, Molly Kinney, Teddy Snyder and Tom McNabb would do exactly what he is doing today. He reiterated that he is not against libraries. His objection is in the way in which the Library Board conducted the process. He feels that they used these tactics because they didn't want the Library to get negative publicity at the time. Commissioner Dunkle stated he will continue this crusade because it was an injustice.

C. Naomi Diehl presentation on her attendance at the National 4-H Congress

Ms. Diehl is a member of the Dairy Club, Steer Club, Sheep and Lamb Club and 4-H Teen Council. She recently attended the National 4-H Congress held in Atlanta Georgia. This was a five-day event that engaged 4-H members in leadership, citizenship and global awareness. She attended various workshops, listened to speakers, visited attractions in Atlanta, gained friendships and attended dances.

D. Zane Swanger - Election Office to host candidate seminar

Mr. Swanger relayed that the Penn State Extension office has cancelled their event, "Throw Your Hat in the Ring" because of the lack of registrations. He explained that he has scheduled an in-house training seminar to be held on February 13, 2019 at 5:30 p.m. at the Annex building for those interested in information in reference to municipal elections. It will be a one-hour presentation and will focus on the election cycle calendar, petition filing and fees, cross filing requirements, statement of financial interests, campaign finance reports, poll-watcher information, public voter information available to candidates and political sign advertising policies. There is no fee to attend this seminar, but pre-registration is required. This seminar is tailored to local municipal offices. Any questions can be directed to the Elections Office.

Commissioner Dunkle commended Mr. Swanger on taking the lead on this seminar. Mr. Swanger has only been with Mifflin County for a short time and has done an outstanding job. An individual with the Department of State recently spoke with Commissioner Dunkle and commended the work Mr. Swanger has done for Mifflin County.

Teresa Hobbs, Mifflin County Democratic Committee Chairperson commented that she appreciates Mr. Swanger and emphasized that he is great to work with. She is very pleased that he has taken the lead in hosting this seminar.

E. Amending the action taken on December 6, 2018 to exonerate Granville Township Tax Collector Billi Weaver from collecting 2018 per capita tax bills as presented (28) – corrected total 17

Motion was made by Commissioner Dunkle to approve amending the action taken December 6, 2018 to exonerate Granville Township Tax Collector Billi Weaver form collecting 2018 per capita tax bills as presented (28) – corrected total 17. Commissioner Postal seconded the motion. The motion was unanimously approved.

F. Amending the action taken on August 30, 2018 to exonerate McVeytown Borough Tax Collector Brooke Knable from collecting 2018 per capita tax bills as presented (6) – corrected total 3

Motion was made by Commissioner Postal to approve amending the action taken August 30, 2018 to exonerate McVeytown Borough Tax Collector Brooke Knable from collecting 2018 per capita tax bills as presented (6) - corrected total 3. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

G. Agreement with Infocon, Ebensburg, PA to create a standardized file transfer program to send the open guardianships to AOPC to the State's Guardianship Tracking System (GTS) for a one-time setup fee of \$250.00 and \$50.00 per month on-going

Motion was made by Commissioner Postal to approve the agreement with Infocon to create a standardized file transfer program to send the open guardianships to AOPC to the State's Guardianship Tracking System (GTS). Commissioner Dunkle seconded the motion. The motion was unanimously approved.

Register and Recorder Stringer said the GTS is a new system from the State. This will help the County communicate with the State regarding guardianships.

H. Contract with Federal Bureau of Corrections

Warden Garver discussed that this contract deals with Federal prisoners awaiting sentencing or already sentenced and awaiting a home prison. They would not be housed for more than six months. Under this contract, we would hold said prisoners until they are moved to their permanent location. No inmates have been assigned to Mifflin County at this point. Several other surrounding Counties house federal prisoners including: Perry, Clinton, Dauphin and Adams. We would have the right to refuse any prisoner.

Commissioner Postal added that this contract must be in place if we want to house federal prisoners.

Motion was made by Commissioner Postal to approve the contract with the Federal Bureau of Corrections. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

I. Conditional approval for a limited topographic survey for the Juniata River Trail, Phase 2 from the EADS Group, Inc., Lewistown, PA - \$7,000.00

Mr. Gomes stated that in 2015, the Commissioners authorized a study that showed there was potential for developing a trail along the Juniata River from Victory Park to Blue Juniata Drive in Granville Township. The study was presented in phases. The first phase was completed in November of 2018 and we would like to continue that effort. We are currently in negotiations with the concrete plant and fire academy. Additionally, we are working with the Borough of Lewistown on this project. We are preparing two applications - \$514,000 for construction and \$83,000 additional costs totaling \$597,000.00. A local match in the amount of \$45,000 to \$50,000 will be required. One of the provisions of the application is to complete a survey of the properties to define the trail appropriately. We are asking for \$7,000.00 to be taken from Act 13 funding and the Planning budget. We have developed a memorandum of understanding with the Borough of Lewistown to define the responsibilities of each party in this proposal. The approval for this topographic study is contingent on the memorandum of understanding being executed by the Borough of Lewistown at their next meeting.

Motion was made by Commissioner Postal to conditionally approve a limited topographic survey for the Juniata River Trail, Phase 2 from the EADS Group, Inc.,

Lewistown, PA - \$7,000.00 contingent upon the Borough of Lewistown approving the memorandum of understanding at their next meeting. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

Commissioner Dunkle added that the memorandum of understanding dictates that the Borough would be responsible for future maintenance, upkeep and liability that may occur on the trail. The Business Borough is contributing \$25,000 toward the required local match and the remaining funding of \$20,000 - \$25,000 has not been finalized.
