VIII. New Business:

A. Amend the action taken on June 3, 2021 to exonerate Granville Township Tax Collector Billi Weaver from collecting 2021 county real estate tax bill No. 17-002706 – corrected amount of tax to be exonerated \$167.95

D. Addendum No. 1 to the Telehealth Services Agreement with InSight Medical Group to provide mental health care services for inmates at the Mifflin County Correctional Facility for the period October 11, 2021 through October 11, 2022

Mr. Kormanic spoke at the meeting and said this is for the psychiatrist who provides mental health resources to incarcerated individuals at the facility.

Motion was made by Commissioner Kodish to be approved. Commissioner Sunderland seconded the motion. The motion was unanimously approved.

E. Linkage letter with Service Access and Management, Inc., Lewistown, PA, to provide counseling services for inmates from Mifflin County Correctional Facility for the period July 1, 2021 through June 30, 2022 and authorize Warden Jason Kormanic to sign the letter

Mr. Kormanic spoke at the meeting and said this is to provide mental health services for incarcerated individuals at the facility. There is no money involved, it is just an agreement to be signed.

Motion was made by Commissioner Kodish to be approved. Commissioner Sunderland seconded the motion. The motion was unanimously approved.

F. Child Welfare Information System Data Sharing Agreement with the Commonwealth of Pennsylvania for the period October 1, 2021 through September 30, 2022

Dana spoke at the meeting and said with this agreement information is shared across all counties in PA. We submit this with our needs based budget every year agreeing that we will participate with this data sharing agreement.

Motion was made by Commissioner Kodish to be approved. Commissioner Sunderland seconded the motion. The motion was unanimously approved.

G. Proposal from J-Way Architectural, Summerhill, PA, for assistance with the courthouse roof replacement bid process - \$6,900.00

Mr. Griffith spoke at the meeting and said this is to hire J-Way Architect to give us a bid proposal for putting rubber roofing on this building. Commissioner Kodish asked how old this roof is and Lonnie said about 15 years (since 2006).

Motion was made by Commissioner Kodish to be approved. Commissioner Sunderland seconded the motion. The motion was unanimously approved.

H. Proposal from J-Way Architectural, Summerhill, PA, to provide a study of the jails existing HVAC system - \$3,800.00

Mr. Griffith spoke at the meeting and said this to hire J-Way Architect as well to look into having the system replaced or partially replaced.

Motion was made by Commissioner Kodish to be approved. Commissioner Sunderland seconded the motion. The motion was unanimously approved.

- I. Application of County Aid 2021 Liquid Fuels Allocation:

J. Program Management Agreement for The Emergency Food Assistance Program (TEFAP)

Allison spoke at the meeting and said this is our yearly agreement with the Department of Agriculture to coordinate and manage the TEFAP program, also known as the commodity program. We work with Salvation Army and the Calvary Bible Church to distribute food.

Motion was made by Commissioner Kodish to be approved. Commissioner Sunderland seconded the motion. The motion was unanimously approved.

K. The Pennsylvania Housing Affordability and Rehabilitation Enhancement Fund 2021 Grant agreement

Allison spoke at the meeting and said this is a competitive grant. It allows us to expand on the homeless preventative program. The program we have through the state only allows 3 months of case management, so we utilize these funds to allow for an extra 3 months of case management. We find the longer we can have them in case management the more effective the program is. The program would then be a total of 6 months. Commissioner Kodish asked how many people are typically in this program and Allison said about 10. We have enough funds to serve 20 people, but it's a program you have to qualify for.

Motion was made by Commissioner Kodish to be approved. Commissioner Sunderland seconded the motion. The motion was unanimously approved.

L. CDBG Hearing

Chastity spoke at the meeting and said there is 2 items to discuss. The first one is the Budget 2018 Modifications. It is the deletion of the Youth Park ADA upgrades to bathrooms project in the amount of \$21,150.00. They returned the funds. We are going to put a portion of the county share into the Wayne Township Infrastructure Improvement Project. Bids were approved and over budget. The second one is the Home Program Application. This is the single family owner occupied program. We are going to apply for \$300,000.00. The application is due August 31, 2021. We are not targeting any specific areas because we have a waiting list that goes back to 2015. There is about 43-44 individuals. We plan to cut into 10 houses with that money. RESOLUTION NUMBER 2021-12

RESOLUTION OF THE MIFFLIN COUNTY COMMISSIONERS AND ON BEHALF OF THE LEWISTOWN BOROUGH COUNCIL, AND THE BROWN, DERRY AND GRANVILLE TOWNSHIP SUPERVISORS RESTATING A FAIR HOUSING POLICY

LET IT BE KNOWN TO ALL PERSONS of the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Brown, Derry and Granville that discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, religion, ancestry, sex, national origin, handicap or disability is prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the Pennsylvania Human Act. It is the policy of Mifflin County and on behalf of The Borough of Lewistown and the Townships of Brown, Derry and Granville to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, ancestry, sex, national origin, handicap or disability, or familial status (families with children). Therefore, the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Brown, Derry and Granville do hereby pass the following resolution.

BE IT RESOLVED, that within available resources the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Brown, Derry and Granville will assist all persons who feel they have been discriminated against because of race, color, religion, ancestry, sex, national origin, handicap or disability, or familial status (families with children) to seek equity under federal and state laws by filing a complaint with the Pennsylvania Human Relations Commission and the U.S. Department of Housing and Urban Development, whichever is chosen by the person filing the complaint.

BE IT FURTHER RESOLVED, that the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Brown, Derry and Granville shall make publicly known this Resolution and through this publicity shall cause owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law, the Pennsylvania Human Relations Act, and any local laws or ordinances.

FURTHER ACTION will at a minimum include, but not to be limited to: (1) Publicizing the name and contact information of the local Fair Housing Officer, which will include the process to file a complaint if a person feels they have been discriminated against in housing in any manner and other applicable fair housing information through local media and community contracts; and (2) Conduct at least one fair housing activity annually to better inform the public of their rights under the Fair Housing Law and Pennsylvania Human Relations Act; and (3) Use the fair housing logo on all materials dealing with housing programs such as but not limited to: (a) Public advertisements for vacancy or discussing the program (b) Applications for assistance (c) Contracts (d) Municipal letters dealing with federal programs.

RESOLUTION OF THE MIFFLIN COUNTY COMMISSIONERS AND ON BEHALF OF THE LEWISTOWN BOROUGH COUNCIL, AND THE BROWN, DERRY AND GRANVILLE TOWNSHIP SUPERVISORS APPOINTING A SECTION 504 COMPLIANCE OFFICER AND ESTABLISHING A GRIEVANCE PROCEDURE

WHEREAS, Mifflin County, Pennsylvania and the Brown, Derry, and Granville Township Supervisors and the Lewistown Borough Council (hereinafter referred to as OBO's), are recipients of federal funds from the Pennsylvania Department of Community and Economic Development (PA- DCED), through the Community Development Block Grant (CDBG) and HOME Investment Partnerships Program, authorized under Title II of the Cranston-Gonzalez National Affordable Housing Act, as amended;

WHEREAS, Mifflin County and its OBO's are statutorily required to develop administrative procedures and regulations in accordance with 24 CFR Part 8 of the Code of Federal Regulations as effectuated on July 11, 1988, to implement Section 504 of the Rehabilitation Act of 1973;

WHEREAS, Mifflin County and the OBO's must designate a Section 504 Compliance Officer who will serve of the County's designated representative for any and all complaints regarding 24 CFR Part 8 of the Code of Federal Regulations and adopt grievance procedures; WHEREAS, Mifflin County outreached with interested parties to solicit input and feed back regarding the County's compliance with administrative rules and regulations related to Section 504 of the Rehabilitation Act of 1973 during 2014;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Mifflin as follows:

1. The Housing Rehabilitation Specialist/Construction Manager, Douglas Marks, of the Mifflin County Planning and Development Department is hereby designated as the County's Section 504 Compliance Officer for 2021 – 2022.

2. The County has adopted a grievance procedure for any and all complaints regarding accessibility to all county owned facilities.

3. The County Commissioners procured the EADS Group Inc. in January 1998 to conduct a comprehensive analysis of all county owned facilities as related to Title II of the American with Disabilities Act. These reports are on file in the Planning and Development Department of the Mifflin County Courthouse.

4. Since 1998 the County Commissioners made modifications to all county owned facilities which comply with Title II of the American with Disabilities Act.

5. The Brown, Derry and Granville Township Supervisors and the Lewistown Borough Council are responsible for complying with Title II of the American with Disabilities Act for all municipal facilities and all facilities are ADA compliant.

NOW, THEREFORE, BE IT RESOLVED, the Mifflin County Board of Commissioners hereby authorizes the filing of an Application for funds with the Department of Community and Economic Development (DCED), Commonwealth of Pennsylvania.:

- 1. The Chairman of the Board of County Commissioners be and is authorized and directed to submit an application, including all understandings and assurances contained therein, to the fullest extent of funds allowed on behalf of the County of Mifflin to the Pennsylvania Department of Community and Economic Development and to act as the authorized representative of the County of Mifflin, and to provide such additional information as may be requested; and
- 2. The Chairman of this Board of Commissioners is hereby authorized and directed to execute on behalf of the County of Mifflin such certifications and/or agreements as may be required to accept and implement the proposed program and activities.
