C. Resolution No. 10 of 2018 Approving Budget Revisions to the FFY 2015 and FFY 2016 CDBG Program on Behalf of Lewistown Borough

RESOLUTION NUMBER 10 of 2018

RESOLUTION OF THE MIFFLIN COUNTY COMMISSIONERS (MCC) ON BEHALF OF THE LEWISTOWN BOROUGH COUNCIL (LBC), APPROVING BUDGET REVISIONS TO THE FFY 2015 AND FFY2016 CDBG PROGRAM

WHEREAS, the LBC and the MCC on behalf of the LBC, funded the South Wayne Street reconstruction projects in FFY 2015, FFY 2016 and the Spring Street project in FFY 2017, in the amounts of \$36,724.00, \$48,630.00, and \$85,170.00 respectively; the projects have been bid and the bid was awarded by the MCC on Thursday, August 30, 2018;

WHEREAS, the low bid in the amount of \$163,361.64 for South Wayne and Spring Streets was over project budgeted funds, in the amount of \$6,571.54 and additional funds are necessary to fully fund these projects;

WHEREAS, the LBC is desirous of decreasing the 2015 ADA ramps with truncated domes project in the amount of \$19,188.93 and increasing the South Wayne Street reconstruction project in the amount of \$19,188.93.

WHEREAS, the LBC is desirous of decreasing the 2016 South Wayne Street project in the amount of \$23,809.55 and adding and funding the 2016 Spring Street project in the amount of \$23,809.55;

WHEREAS, the MCC on behalf of the LBC adopted Resolution 10-2018 at their September 6, 2018 public meeting, approving aforementioned budget revisions and authorized the Mifflin County Planning and Development Department to submit said budget revision documentation to the PA-DCED for review and approval,

WHEREAS, it is the requirement of the Pennsylvania Department of Community and Economic Development (PA-DCED), to revise the Lewistown's Borough's 2015 and 2016 program funding budgets, so as to complete the following actions:

- 1. Decrease the FFY 2015 ADA ramps with truncated domes project in the amount of \$19,188.93.
- 2. Increase the FFY 2015 South Wayne Street project in the amount of \$19,188.93;
- 3. Decrease the FFY 2016 South Wayne Street project in the amount of \$23,809.55
- 4. Add the FFY 2016 Spring Street project and fund it in the amount of \$23,809.55.

NOW, THEREFORE, BE IT RESOLVED, by the MCC on behalf of the LBC as follows:

- 1. That the program revisions affecting the Borough's 2015 and 2016 program budgets are approved through the adoption of this Resolution.
- 2. That the Mifflin County Planning and Development Department is authorized to complete and submit said revision requests and required documentation to the (PA- DCED) for review and approval.

Mr. Lettiere read over Resolution No. 10 detailing the requested budget changes. He explained that this project was on the fast track because Lewistown Borough would like to have it completed by the end of the year.

Motion was made by Commissioner Postal to approve Resolution No. 10 of 2018 Approving Budget Revisions to the FFY 2015 and FFY 2016 CDBG Program on Behalf of Lewistown Borough. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

D. Resolution No. 11 of 2018 Approving Budget Revisions to the FFY 2015 CDBG Program

RESOLUTION NUMBER 11 of 2018

RESOLUTION OF THE MIFFLIN COUNTY COMMISSIONERS (MCC) APPROVING BUDGET REVISIONS TO THE FFY 2015 CDBG PROGRAM

WHEREAS, the MCC, funded the West Wayne Township Sewer reconstruction project in FFY 2016, in the amount of \$105,600.00 and the project has been bid and the low bid was provided by HRI, Inc. of State College, PA in the amount of \$149,425.00 and the award was approved by the MCC at their August 30, 2018 public meeting;

WHEREAS, the low bid in the amount of \$149,425.00 exceeds the allocated project budgeted funds leaving a deficit in the amount of \$59,425.00 and additional funds are necessary to fully fund the project;

WHEREAS, on August 23, 2018, the West Wayne Township Sewer Authority has committed funds in the amount of \$14,000.00 towards the deficit, leaving a deficit balance of \$45,425.00; there are available project funds in the amount of \$67,926.00 in FFY 2015 County-wide, single-family, housing rehabilitation project to cover this shortfall;

WHEREAS, the MCC is desirous of decreasing the FFY 2015 County-wide, single-family, housing rehabilitation project, in the amount of \$45,425.00 and adding \$45,425.00 in project funds in FFY 2015 towards the West Wayne Township Sewer reconstruction project, to fully fund the project, leaving a new project balance in the amount of \$22,501.00 in FFY 2015 for the County-wide, single-family, housing rehabilitation project;

WHEREAS, it is the requirement of the Pennsylvania Department of Community and Economic Development (PA-DCED), to revise Mifflin County's 2015 program budget, so as to complete the following actions:

- 1. Decrease the FFY 2015 County-wide, single-family, housing rehabilitation project, in the amount of \$45,425.00 leaving a balance of \$22,501.00 for project and delivery costs.
- 2. Increase the FFY 2015 West Wayne Township Sewer reconstruction project in the amount of \$45,425.00 totaling \$45,425.00.

NOW, THEREFORE, BE IT RESOLVED, by the MCC:

- 1. That the program revisions affecting the County's FFY 2015 budget are approved through the adoption of this Resolution.
- 2. That the Mifflin County Planning and Development Department is authorized to complete and submit said revision requests and required documentation to the (PA- DCED) for review and approval.

Mr. Lettiere read over Resolution No. 11 detailing the requested budget revisions. This project will likely be finished by the end of the year.

Mr. Postal asked if funds are sitting in the single-family, housing rehabilitation project because there isn't a demand for said funding.

Mr. Lettiere explained that almost every year through their allocation of CDBG funds, they fund the single-family housing rehabilitation project as a safeguard for additional money. There is a demand for this funding, but there is also additional funding available in the Home program that needs to be expended by the end of July 2019. He feels that there is ample funding in the single-family housing rehabilitation program through other fiscal years that moving this money around will not cause any adverse effects on the program.

Motion was made by Commissioner Postal to approve Resolution No. 11 of 2018 Approving Budget Revisions to the FFY 2015 CDBG Program. Commissioner Dunkle seconded the motion. The motion was unanimously approved.
