D. Greenways, Trails and Recreation Program Grant Agreement

Commissioner Postal explained this is an agreement through the Commonwealth Financing Authority through the Pennsylvania Department of Community and Economic Development to extend the existing Rothermel Trail. This grant is for \$200,000.00.

Chairman Kodish that this is accepting the grant and gives us up to three years to execute it.

Motion was made by Commissioner Postal to approve the Greenways, Trails and Recreation Program Grant Agreement. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

G. SAVIN (Statewide Automated Victim Information and Notification System) maintenance and service agreement with the Pennsylvania District Attorney's Institute – January 1, 2020 through December 31, 2020

Warden Garver explained this is a victim notification system that notifies victims when an inmate has been released. It was formerly called the Victims Information and Notification Every day or VINE system. This connects to all correctional facilities in the state of PA. This maintenance and service agreement is no cost to the County.

Motion was made by Commissioner Postal to approve the SAVIN maintenance and service agreement with the Pennsylvania District Attorney's Institute – January 1, 2020 through December 31, 2020. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

H. Memorandum of Understanding between the Commissioners and Granville Township Supervisors for the Demolition of 15 and 17 Henrietta Street

Mr. Lettiere explained this memorandum of understanding is the contractual obligation between the Commissioners and Granville Township for utilizing \$10,000.00 of Act 152 funds for the demolition of 15 and 17 Henrietta Street. In the event the property is sold, 15% of the proceeds will return to the County. The total bid is \$66,700.00 with \$10,000.00 coming from Act 152 funding and the balance coming from Granville Township's CDBG money.

Commissioner Postal mentioned this is another project the County is participating in through the blight remediation program. He invited all municipalities to contact the Planning Department for information on how to apply for a blight remediation project in their municipality.

Motion was made by Commissioner Postal to approve the memorandum of understanding between the Commissioners and Granville Township Supervisors for the Demolition of 15 and 17 Henrietta Street. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

- I. Award bid for the CDBG 15 and 17 Henrietta Street Demolition Project:

*Mr. Marks stated this project will help the community by getting rid of blight and cleaning up the area. The project should begin in late January or early February.*

K. Appointment of David Filson, Lewistown, PA to the Mifflin County Conservation District Board of Directors to fill an unexpired term – term expires December 31, 2021:

Motion was made by Commissioner Dunkle to approve the appointment of David Filson to the Mifflin County Conservation District Board of Directors to fill an unexpired term – term expires December 31, 2021. Commissioner Postal seconded the motion. The motion was unanimously approved.

Commissioner Dunkle explained this position was formerly held by Roy Stine who has recently passed away. Mr. Stine was a member of the Conservation District since 1972, one of the longest consecutive serving members in the history of the Commonwealth.

L. Application for GEMS Program Funds for partial reimbursement of voting equipment - \$156,201.00

Chairman Kodish added this is the State program using bonds to fund the reimbursement to Counties up to 60% for new voting equipment that was purchased. Application must be made to the State for that funding.

Motion was made by Commissioner Postal to approve the application for GEMS Program Funds for partial reimbursement of voting equipment - \$156,201.00. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

Commissioner Dunkle shared his displeasure with this mandate. He mentioned that Mifflin County had equipment that met the requirements of the State. He feels this is unnecessary government spending.

M. Personnel:

Motion was made by Commissioner Postal to approve the hiring of William Gomes for part-time Planning Director effective January 1, 2020 for a 45 day period or less. Commissioner Dunkle seconded the motion. The motion was unanimously approved.

Motion was made by Commissioner Dunkle to accept the above three personnel items. Commissioner Postal seconded the motion. The motion was unanimously approved.

Solicitor Snook acknowledged long-time Court Reporter Alice Arnold for the great work she's done for Mifflin County. He mentioned that she worked tirelessly and did an excellent job.

Chairman Kodish announced there will be no public meeting on January 2, 2020. There will be regular meetings on Thursday, January 16, 2020 and Thursday, January 30, 2020. There will be a reorganizational meeting on Monday, January 6, 2020.

With this being the last meeting of the current term, Chairman Kodish thanked his colleagues for working with him. He stated every term is different. In this next term, Commissioner Dunkle will be heading into retirement and former Commissioner Sunderland will be returning. He then thanked the Commissioners' Office front office staff for the work they do. He thanked the other elected officials for their help as well.
