VIII. New Business:

Motion was made by Commissioner Dunkle to approve the request for exoneration of 2017 per capita taxes. Seconded by Commissioner Postal. The motion was unanimously approved.

B. Rescind action taken on November 2, 2017 to exonerate Armagh Township Tax Collector Linda Marks from collecting 2017 per capita tax bill as presented (9) – they were school district exonerations.

Motion was made by Commissioner Postal to rescind action taken on November 2, 2017. Seconded by Commissioner Dunkle. The motion was unanimously approved.

- C. Request for real estate tax refund:
 - Parcel No. 13,04-135A located in Bratton Township a mobile home was removed from the property County portion \$289.74

Motion was made by Commissioner Dunkle to approve the request for real estate tax refund. Seconded by Commissioner Postal. The motion was unanimously approved.

D. Coroner cremation fees increase to \$60.00 effective January 1, 2018

Coroner Lynch stated that the current cremation fee is \$25.00 and has been at that rate for at least 15 years. In order to make the fee more consistent with other counties in the

state, he suggests raising the fee to \$60.00. This fee is used for training and education of the Coroner's office staff.

Motion was made by Commissioner Postal to approve the increase in cremation fees. Seconded by Commissioner Dunkle. The motion was unanimously approved.

E. Reappointment of Wilda Fisher, McVeytown, PA, for a five-year term on the Mifflin County Housing Authority

Motion was made by Commissioner Postal to approve the Appointment and Reappointment to the Mifflin County Library Board. Seconded by Commissioner Dunkle. The motion was unanimously approved.

J. Personnel:

Motion was made by Commissioner Postal to accept the above personnel items. Seconded by Commissioner Dunkle. The motion was unanimously approved.

K. Display the 2018 budget on Friday, November 17, 2017 with final adoption scheduled for December 7, 2017

Chairman Kodish explained that the budget is \$29.8 million reflecting a tax decrease of .23 mills, which amounts to a little over \$200,000.

Motion was made by Commissioner Postal to display the 2018 budget on Friday, November 17, 2017. Chairman Kodish stepped from Chair to second the motion. The motion was approved 2 - 1 with Commissioner Postal and Chairman Kodish in favor and Commissioner Dunkle opposed.

Commissioner Dunkle stated that he opposed this budget because he felt there could have been a deeper tax decrease made.

Commissioner Postal said that he voted in favor of the budget because he felt it would be imprudent to go into next year without a sufficient cushion given the uncertainty with the budget at the State level. He also stated he feels it's a fair budget.

Chairman Kodish added that he echoes the thoughts of Commissioner Postal. He mentioned that the budget is balanced and that some of the reserve has been used so that the tax decrease could take place. This will slightly relieve the burden on the taxpayers and any more of a decrease would have caused deficit spending in 2018.

Commissioner Dunkle further clarified his position by saying that there is a projected carryover balance of approximately \$850,000 and there was a recent investment of \$3 million in a Certificate of Deposit. Of that \$3 million, a substantial amount is dedicated or encumbered to grants that have been received for special programs. He believes that even with that amount, which is roughly \$1,105,000, and the establishment of a rainy day fund in the amount of \$500,000, the cuts could have been a little deeper.
