#### VIII. New Business:

A. Proclamation Honoring Clifford G. Walters

#### Clifford G. Walters Proclamation

WHEREAS, Clifford G. Walters of Reedsville is recognized for his life-long preservation of Hoopes School, built in 1873, located at 867 Long Lane, Derry Township, Mifflin County. Abandoned in 1958 as a school and for sale, Mr. Walters acquired the building in 1974 and through decades of dedication and personal expense, created a living museum reflecting rural education in Mifflin County in the nineteenth and twentieth centuries. He originally opened the school to the public July 4, 1976 and has been open annually ever since; and

WHEREAS, Thanks to Mr. Walters' efforts, the Hoopes School is on the National Register of Historic Places and recognized architecturally, as an excellent example of a central Pennsylvania one-room schoolhouse, the standard educational facility for rural America throughout the history of education in this country; and

**FURTHERMORE,** Mr. Walters, in his desire to see Hoopes School preserved for future generations, donated the property, building and its collected rural school related contents to the Mifflin County Historical Society for extended preservation;

**NOW, THEREFORE**, We, the Mifflin County Commissioners do hereby commend Mr. Walters' dedication for preserving a part of Mifflin County's educational heritage and Mr. Walters is to be recognized and highly commended

Mr. Walters expressed how thankful he was to receive this proclamation.

Mr. Fisher, current Vice President of Mifflin County Historical Society spoke on behalf of Steve Rynklewitz, President of Mifflin County Historical Society who couldn't attend the meeting. Mr. Fisher spoke and said for the better part of 50 years, Cliff Walters per sued his lifelong dedication to preserve the old Hoopes School in Derry Township. The 1873 brick building was among the last four (4) one room schools to operate in Mifflin County when it closed in 1958. The Hoope School came on the market in 1974. The successful bid from Cliff and his late with Joann started the Walters family decade long journey. The school was left with an old coal stove. The Walters had a goal of opening the school on July 4, 1976. They needed everything you could imagine that was in a one room school, such as books, desks, maps, slate, and lunch boxes. Cliff kept the school open from 1976-2021. Cliff approached the Historical Society early 2021 with the offer turning over the example of rural education to the society for preservation into the future. The transfer was completed in November 2021. He said Cliff's gesture is very much appreciated and they thank him and his family.

SECRETARY'S CERTIFICATE. I certify that I am the Secretary of MIFFLIN COUNTY ('Entity'), a government entity in good standing under the laws of Pennsylvania. The following is an accurate copy of resolutions adopted by the Entity's governing body at a meeting properly called and held on December 30, 2021, at which a quorum was present. RESOLVED, that THE JUNIATA VALLEY BANK ('Bank') is designated a depository of funds for the Entity;

RESOLVED, that the Bank is authorized to honor, pay, and charge the Entity's account(s) for any item purporting to have been signed on behalf of the Entity with a facsimile signature that resembles a specimen the Entity has certified to the Bank, no matter by whom or by what means the actual or purported signature may have been made;

RESOLVED, that the persons named below, whose manual and/or facsimile signatures are provided next to their respective names, are authorized to sign and authorize checks, drafts, withdrawal slips, and any other orders for the payment of money, whether by paper, electronic, or other means, even if payable to the signer or used to discharge or reduce any obligation of the signer. The Bank has no duty to inquire into any such action before executing it, even if the action benefits the signer individually. Number of signatures required: 2.

RESOLVED, that the Secretary of the Entity is directed to certify and deliver a copy of these resolutions to the Bank, the signature cards bearing the genuine signatures of the persons named below, and any other documents that the Bank requires.
