RESOLUTION NUMBER 2022-1

A resolution of the Mifflin County Commissioners, County of Mifflin, Commonwealth of Pennsylvania, authorizing the submission of an application to the Pennsylvania Department of Community and Economic Development for funding through the Community Development Block Grant (CDBG) Program, as authorized under the Housing and Community Development Act [42 USC 5301 and 24 CFR Part 570], and further certifying compliance with the requirements of said program.

WHEREAS, it is necessary and in the public interest that the Mifflin County Commissioners and on behalf of the Granville Township Supervisors receive funds from the Commonwealth through the Department of Community and Economic Development in accordance with the Community Development Block Grant; and

WHEREAS, the Mifflin County Commissioners and on behalf of the Granville Township Supervisors have the legal authority and responsibility under Act 179 to apply for Community Development Block Grant Programs; and **WHEREAS**, the Mifflin County Commissioners and on behalf of the Granville Township Supervisors have undertaken a considerable citizen participation process including written invitations to municipalities, informational meetings, hearings and legal notices all of which culminated in the prioritization of projects and development of a Community Development Plan; and

WHEREAS, The Mifflin County Commissioners and on behalf of the Granville Township Supervisors are familiar with the requirements of the program as provided for in the Housing and Community Development Act (HCDA) and the CDBG regulations; and

WHEREAS, Mifflin County, Mifflin County, PA is eligible to apply for \$2,816,809.00 in federal funds from the Pennsylvania Department of Community and Economic Development under the FFY 2021 CDBG Discretionary or Competitive program, and

WHEREAS, the Mifflin County Commissioners and on behalf of the Granville Township Supervisors wish to apply for said funds.

NOW, THEREFORE, BE IT RESOLVED by the Mifflin County Commissioners as follows:

a. The FFY 2021 CDBG Discretionary/Competitive application is hereby approved for the proposed activities listed below:

b. That the Mifflin County Planning and Development Department is authorized and directed to have prepared the necessary forms and documents on behalf of the Mifflin County Commissioners to submit an application to the Department of Community and Economic Development for CDBG funds for the purposes aforesaid.

c. If CDBG funds are determined by the Pennsylvania Department of Community and Economic Development to be expended on ineligible program costs or do not meet a national objective, the Mifflin County Commissioners agree to repay the proportion deemed ineligible from non-federal resources.

d. The Community Development Plan was developed in coordination with low and moderate individuals, interested organizations, non-profits and other interested parties through the citizen participation process and municipal information gathering is hereby adopted.

e. The Chairman of the Board of Commissioners of Mifflin County as appropriate is empowered to place his/her signature, on behalf of the governing body, on necessary application forms and affix thereto the official seal of Mifflin County.

RESOLUTION NUMBER 2022-2

RESOLUTION OF THE MIFFLIN COUNTY COMMISSIONERS (MCC) ON BEHALF OF THE DERRY TOWNSHIP SUPERVISORS (DTS) APPROVING BUDGET REVISIONS TO THE FFY 2018 CDBG PROGRAM

WHEREAS, the Derry Township Supervisors (DTS) and the Mifflin County Commissioners (MCC) on behalf of the DTS, funded the East Walnut Street Extended Street Reconstruction Project in FFY 2018 and completed the activity and there are unused funds in the amount of \$22,962.77;

WHEREAS, the DTS and the MCC on behalf of the DTS, funded the single-family, housing rehabilitation program in FFY 2018, in the amount of \$7,065.00;

WHEREAS, the DTS and the MCC on behalf of the DTS are desirous of moving the remaining funds from the East Walnut Street Extended Street Reconstruction Project to the single-family housing rehabilitation project;

WHEREAS, the DTS adopted a resolution on January 3, 2022 approving said budget revisions and authorized the Mifflin County Planning and Development Department to complete and submit said revision request and required documentation to the (PA- DCED) for review and approval;

WHEREAS, it is the requirement of the Pennsylvania Department of Community and Economic Development (PA-DCED), to revise the Township's 2018 program funding budgets, so as to complete the following actions:

- 1. *Reduce the FFY 2018 East Walnut Street Extended Street Reconstruction project by the amount of \$22,962.77.*
- 2. Increase the FFY 2018 Single-family, housing rehabilitation project to a new balance of \$30,027.77.

NOW, THEREFORE, BE IT RESOLVED, by the MCC as follows:

- 1. That the program budget revisions affecting the Derry Township 2018 program budgets are approved by the MCC on behalf of the DTS through the adoption of this Resolution.
- 2. That the Mifflin County Planning and Development Department is authorized to complete and submit said revision request and required documentation to the (PA-DCED) for review and approval.
