- A. Juniata River Valley Visitors Bureau, Executive Director, Jenny Barron Landis Act 13 Project Monument repair work at Old Town Cemetery:
 - Atlas Preservation, Inc. \$4,250.00

Ms. Landis explained the Old Town Cemetery is located on the corner of S. Brown and Water Streets. This cemetery holds some of the first European settlers in the area including that of Dorcas Buchanan. The cemetery is owned and maintained by the county but no ongoing preservation has been done. Some well-meaning people have recently made changes but the methods they used are not recommended by professionals who work with old headstones. Ms. Landis noted that sometimes new materials can actually damage older headstones. Jonathan Appell is the owner of Atlas Preservation, Inc. and an expert in the field of gravestone preservation and restoration. He was previously in the area and led a workshop on grave preservation. Jonathan will now be returning this October to repair damaged stones and rework changes already made. One of the county maintenance personnel will follow Jonathan through the process so there will be a local person who will be able follow the correct steps to continue preserving the monuments.

Commissioner Postal noted the importance of preserving local monuments. He also clarified funds for this project will be coming from Act 13, commonly known as Marcellas Shale, and will not be a cost to the county general fund.

Ms. Landis then took a moment to also bring attention to the upcoming Goose Day celebrations around the area. She provided the Commissioners with flyers listing the events and festivities of the occasion.

Motion was made by Commissioner Postal to be approved. Commissioner Kodish seconded the motion. The motion was unanimously approved.
