RESOLUTION OF THE MIFFLIN COUNTY COMMISSIONERS AND ON BEHALF OF THE LEWISTOWN BOROUGH COUNCIL, AND THE ARMAGH, BROWN, DERRY AND GRANVILLE TOWNSHIP SUPERVISORS FAIR HOUSING RESOLUTION



LET IT BE KNOWN TO ALL PERSONS of the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Armagh, Brown, Derry and Granville that discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, sex (including gender identity and sexual orientation), national origin, religion, familial status(families with children), or handicap (disability) is prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Act) and the Pennsylvania Human Relations Act adds the additional protected classes of age, ancestry and use of guide or support animals because of the blindness, deafness or physical handicap of the user or because the user is a handler or trainer of support or guide animals. It is the policy of the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Armagh, Brown, Derry and Granville to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, sex (including gender identity and sexual orientation), national origin, religion, familial status, handicap, age, ancestry and use of guide or support animals because of the blindness, deafness or physical handicap of the user or because the user is a handler or trainer of support or guide animals. Additionally, it is illegal to retaliate against a person who has filed a fair housing complaint or assisted in a fair housing investigation. Therefore, the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Armagh, Brown, Derry and Granville does hereby pass the following resolution.

BE IT RESOLVED, that within available resources the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Armagh, Brown, Derry and Granville will assist all persons who feel they have been discriminated against because of race, color, sex (including gender identity and sexual orientation), national origin, religion, familial status, handicap, age, ancestry and use of guide or support animals because of the blindness, deafness or physical handicap of the user or because the user is a handler or trainer of support or guide animals to seek equity under federal and state laws by filing a complaint with the local Fair Housing Officer, Pennsylvania Human Relations Commission and the U.S. Department of Housing and Urban Development, whichever is chosen by the person filing the complaint.

BE IT FURTHER RESOLVED that the County of Mifflin, and on behalf of The Borough of Lewistown and the Townships of Armagh, Brown, Derry and Granville shall make publicly known this Resolution and through this publicity shall cause owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Act, the Pennsylvania Human Relations Act, and any local laws or ordinances.

FURTHER ACTION will at a minimum include, but not to be limited to:

- (1) Publicizing the name and contact information of the local Fair Housing Officer, which will include the process to file a complaint if a person feels they have been discriminated against in housing in any manner and other applicable fair housing information through local media and community contracts; and
- (2) Conduct at least one fair housing activity annually to better inform the public of their rights under the Fair Housing Law and Pennsylvania Human Relations Act; and
- (3) Use the fair housing logo on all materials dealing with housing programs such as but not limited to:

- a. Public advertisements for vacancy or discussing the program
- b. Applications for assistance
- c. Contracts
- d. Municipal letters dealing with the federal programs

RESOLUTION OF THE MIFFLIN COUNTY COMMISSIONERS AND ON BEHALF OF THE LEWISTOWN BOROUGH COUNCIL, AND THE ARMAGH, BROWN, DERRY AND GRANVILLE TOWNSHIP SUPERVISORS APPOINTING A SECTION 504 COMPLIANCE OFFICER AND ESTABLISHING A GRIEVANCE PROCEDURE

WHEREAS, Mifflin County, Pennsylvania and the Armagh, Brown, Derry, and Granville Township Supervisors and the Lewistown Borough Council (hereinafter referred to as OBO's), are recipients of federal funds from the Pennsylvania Department of Community and Economic Development (PA- DCED), through the Community Development Block Grant (CDBG and CDBG Discretionary) and HOME Investment Partnerships Program, authorized under Title II of the Cranston-Gonzalez National Affordable Housing Act, as amended;

WHEREAS, Mifflin County and its OBO's are statutorily required to develop administrative procedures and regulations in accordance with 24 CFR Part 8 of the Code of Federal Regulations as effectuated on July 11, 1988, to implement Section 504 of the Rehabilitation Act of 1973;

WHEREAS, Mifflin County and the OBO's must designate a Section 504 Compliance Officer who will serve of the County's designated representative for any and all complaints regarding 24 CFR Part 8 of the Code of Federal Regulations and adopt grievance procedures;

WHEREAS, Mifflin County outreached with interested parties to solicit input and feed back regarding the County's compliance with administrative rules and regulations related to Section 504 of the Rehabilitation Act of 1973 during 2014;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Mifflin as follows:

- The Community Development Administrator, Chastity Fultz, of the Mifflin County Planning and Development Department is hereby designated as the County's Section 504 Compliance Officer for 2023 – 2024.
- The County has adopted a grievance procedure for any and all complaints regarding accessibility to all county owned facilities.
- The County Commissioners procured the EADS Group Inc. in January 1998 to conduct a comprehensive
 analysis of all county owned facilities as related to Title II of the American with Disabilities Act. These reports
 are on file in the Planning and Development Department of the Mifflin County Courthouse.
- Since 1998 the County Commissioners made modifications to all county owned facilities which comply with Title II of the American with Disabilities Act.
- The Armagh, Brown, Derry and Granville Township Supervisors and the Lewistown Borough Council are responsible for complying with Title II of the American with Disabilities Act for all municipal facilities and all facilities are ADA compliant.

A resolution of the Board of Commissioners, County of Mifflin, Commonwealth of Pennsylvania, establishing, pursuant to 16 P.S. § 2306, the fair market value of the property located at 399 Green Avenue Extended, Lewistown, PA 17044, and authorizing the Chairman of said Board of Commissioners of Mifflin County to sign, on behalf of the County of Mifflin, an Agreement of Sale with the high bidder following the sealed bid opening on July 20, 2023.

WHEREAS, the County is the owner of real property, together with improvements thereon, situate at 399 Green Avenue Extended, Lewistown, PA 17044 (the "Property"), and more fully identified at Mifflin County Tax Map Reference No. 16,11-0100--,000; and

WHEREAS, the County determined that it was in the best interest of the County to sell the Property; and

WHEREAS, the County procured the services of a duly qualified auctioneer who adequately marketed and advertised the Property prior to a public auction held on March 30, 2023; and

WHEREAS, after competitive bidding, the high bidder at the public auction offered a high bid price of Two Hundred Thousand and No/100 Dollars (\$200,000.00); and

WHEREAS, the aforesaid high bidder at the public auction thereafter refused to continue with settlement on the Property and thereafter rescinded his offer to purchase the Property; and

WHEREAS, the Property was offered to the next-highest-bidder at a proposed purchase price of One Hundred Ninety-Five Thousand and No/100 Dollars (\$195,000.00); and

WHEREAS, the next-highest-bidder refused to purchase the Property at the aforesaid proposed purchase price; and

WHEREAS, the remaining tenant in the Property as of the date of the aforesaid public auction provided notice that it was terminating its lease and vacating the property effective August 1, 2023, leaving the property one hundred percent (100%) vacant: and

WHEREAS, the Board of Commissioners of Mifflin County determined that it was in the best interest of the County to offer the Property through a sealed bid process, which was authorized at a duly held public meeting on June 15, 2023; and

WHEREAS, the Board of Commissioners of Mifflin County duly advertised the accepting of sealed bids, and the terms thereof, for the Property in a local newspaper of general circulation, the Lewistown Sentinel, on June 21, 2023; and

WHEREAS, one (1) sealed bid was received and opened at the duly held public meeting on July 20, 2023, from MAB Holding, LLC, in the amount of One Hundred One Thousand and No/100 Dollars (\$101,000.00); and

WHEREAS, 16 P.S. 2306 of the Pennsylvania County Code requires that the fair market value of property to be sold by County commissioners "shall be determined by the commissioners in consultation with two of the following: the county assessor, certified broker-appraisers, or certified real estate appraisers doing business within the County"; and

WHEREAS, the Board of Commissioners of Mifflin County consulted with a certified real estate appraiser and the County assessor; and

WHEREAS, the Board of Commissioners determined that, given the adequate marketing and advertising completed for the Property, the ample time for any prospective buyer to attend and bid on the Property, the prior activity with regard to the Property, and the change in vacancy status following the property public auction, the high bid of One Hundred One Thousand and No/100 Dollars (\$101,000.00) established through the duly advertised and announced sealed bid process is indicative of the fair market value of the Property; and

WHEREAS, the Board of Commissioners are desirous of establishing the fair market value of the Property, as required under the aforesaid statute, at the high sealed bid amount of One Hundred One Thousand and No/100 Dollars (\$101,000.00); and

WHEREAS, the Board of Commissioners is desirous of accepting the high sealed bid amount from MAB Holdings, LLC, and authorize the Chairman of the Board of Commissioners to execute the Sales Agreement executed by Michael Buffington, President of MAB Holdings, LLC, for the sale of the Property under the terms and conditions contained therein for a purchase price equal to the established fair market value of One Hundred One Thousand and No/100 Dollars (\$101,000.00).

NOW, THEREFORE, BE IT RESOLVED by the County Board of Commissioners for Mifflin County, Pennsylvania, as follows:

 All of the recital clauses set forth above are incorporated herein as if more fully set forth.

- At the aforesaid sealed bid opening for the Property, the high bidder was MAB Holdings, LLC, at a purchase price bid of One Hundred One Thousand and No/100 Dollars (\$101,000.00).
- Pursuant to 16 P.S. § 2306, after consultation with a certified real estate appraiser and the County assessor, the Commissioners of Mifflin County hereby establish the fair market value of the Property to be One Hundred One Thousand and No/100 Dollars (\$101,000.00).
- 4. The Board of Commissioners of Mifflin County hereby accept the sealed bid from MAB Holdings, LLC, at the aforesaid purchase price and under the terms and conditions contained in the hereinafter Sales Agreement. A copy of the Sales Agreement is attached hereto as Schedule "A".
