G. Professional and Administrative Services with SEDA-Council of Governments, Lewisburg, PA for the administration of the Community Development Black Grant Program for Mifflin County and on behalf of the Townships of Armagh, Brown, Derry, and Granville and the Borough of Lewistown:

Planning Director James Lettiere stated these agreements represent the contractual obligation between the county and SEDA-COG for all open contracts for administration for the Community Development Block Grant program. Within each agreement there are categories of activities that are delineated which are to be undertaken by SEDA-COG in conjunction with the Mifflin County Planning office. Those activities are grant administration, activity development, and activity management. There is a cost to each activity. The method used to determine the cost for each activity was derived from the complexity of the project, the amount in the budget, the time it would take to do the environmental reviews, consideration to fund a full-time Grant Liaison position, and use of portions of the county funds zoning towards the comprehensive plan.

Tyler Dombroski, Director of Community Development Program for SEDA-COG, gave a brief explanation of SEDA-COG's rule in this process. He stated there are 15 staff members in the department with expertise in the environmental review process, labor standards, and procurement. The department as a whole, has 40 years of experience in managing CDBG programs.
