A. Proclamation for the 115th Anniversary of the General Thomas Mifflin Chapter of the Daughters of the American Revolution (Dorothy Messimer, Chapter Regent and Sandy Dedmon)

PROCLAMATION FOR THE 115^{TH} ANNIVERSARY OF THE GENERAL THOMAS MIFFLIN CHAPTER OF THE DAUGHTERS OF THE AMERICAN REVOLUTION

Whereas, The National Society Daughters of the American Revolution was founded on October 11, 1890 at a time when women felt a desire to express their patriotic feelings when they could not be included in men's organizations; and

Whereas, the DAR's objectives of historical preservation, educational and patriotic service to the country has remained the same for the past 125 years; and

Whereas, the General Thomas Mifflin Chapter of the DAR was organized on October 7, 1908; and

Whereas, the General Thomas Mifflin Chapter of the DAR is comprised of members from Juniata, Mifflin, and Perry Counties; and

Whereas, the members of the General Thomas Mifflin Chapter of the DAR have contributed countless hours of volunteer service to various causes over the past 115 years; and

Whereas, the members of the General Thomas Mifflin Chapter of the DAR are part of over a million members of the DAR; and

Now, therefore, be it resolved that the Mifflin County Commissioners do hereby proclaim October 7, 2023 as the 115th anniversary of the General Thomas Mifflin Chapter of the DAR.

Proclaimed this 5th day of October, 2023

Dorothy Messimer explained each daughter of the society highlights the importance of historical preservation, education, and patriotism. Service to America is one of their programs where each daughter donates her time to various endeavors. Daughters have donated their time not only to their own communities but also travel to other communities across the state to assist other chapters to honor revolutionary patriots, clean cemeteries, collect items for soldiers and veterans. There are over ninety chapters in Pennsylvania. The daughters in this local chapter donate their time to the Boy Scouts, their churches, serve on non-profit boards, grow vegetables for food banks, and place flags on patriots' graves on Memorial Day among other activities. This local chapter has donated approximately 800 hours to various entities in Pennsylvania.

Motion was made by Commissioner Kodish to be approved. Commissioner Sunderland seconded the motion. The motion was unanimously approved.

B. FFY 2023 Second Public Hearing CDBG

CDBG Administrator Chastity Fultz hosted the second CDBG Public Hearing for FFY 2023. The hearing began at 9:12 am. Ms. Fultz stated the purpose of the hearing is to announce the projects that have been selected to fund with this year's application and to give the public a chance to offer any comments, questions, or concerns. Ms. Fultz presented the allocations as follows:

Ms. Fultz then reported the approved projects as listed in Resolution No. 31 of 2023.

For Mifflin County Ms. Fultz noted the Lockport Stormwater Improvements Project was partially funded last year with commitment of total funds this year. Ms. Fultz stated only one application was received for County funds this year. The application came from Wayne Township who needs to upgrade water meters in the Shaverville Circle area and former Methodist campground area just outside of Newton Hamilton. Wayne Township has 85 customers receiving public water. Their current water meters are over twenty years old and having a lot of leaking issues. The township will be putting all the meters in a water meter pit at the public right of way. This will help determine if there is a leak through a notification warning of high usage which in turn, will prompt repairs. This is approximately a \$300,000 project. This year \$103,403.00 will be attributed to the project. All of next years funds will be allocated to the project and some of 2025 funds will also be applied to cover the costs. Administration fees of \$40,177 will go to the Mifflin County Planning and Development Department to cover the cost of salaries and staff operating costs.

Ms. Fultz then proceeded to recite the remainder of the projects and associated funds as listed for all other entities involved. Once all were announced, Ms. Fultz opened the floor to public comment.

Commissioner Kodish asked Ms. Fultz to explain some of the qualification that have to be considered when reviewing applications. Ms. Fultz state they must meet one of three national objectives. The three objectives are low to moderate income, demolition, or urgent need. They cannot cover regular maintenance or do an area where regular government business is held. Projects are limited to infrastructure repair, move, or extension.

With no other public questions or comments, the hearing concluded at 9:20 am.

C. Resolution No. 31 of 2023 Authorizing the submission of the FFY 2023 CDBG application

RESOLUTION NUMBER 2023-31

A resolution of the Mifflin County Commissioners, County of Mifflin, Commonwealth of Pennsylvania, authorizing the submission of an application to the Pennsylvania Department of Community and Economic Development for funding through the Community Development Block Grant (CDBG) Program, as authorized under the Housing and Community Development Act [42 USC 5301 and 24 CFR Part 570], and further certifying compliance with the requirements of said program.

WHEREAS, it is necessary and in the public interest that the Mifflin County Commissioners and on behalf of the Armagh, Brown, Derry and Granville Township Supervisors and Lewistown Borough Council, Pennsylvania, receive funds from the Commonwealth through the Department of Community and Economic Development in accordance with the Community Development Block Grant program; and

WHEREAS, the Mifflin County Commissioners and on behalf of the Armagh, Brown, Derry and Granville Township Supervisors and Lewistown Borough Council have the legal authority and responsibility under Act 179 to apply for Community Development Block Grant funds; and

WHEREAS, the Mifflin County Commissioners and on behalf of the Armagh, Brown, Derry and Granville Township Supervisors and Lewistown Borough Council have undertaken a considerable citizen participation process including written invitations to municipalities, informational meetings, hearings and legal notices all of which culminated in the prioritization of projects and development of a Community Development Plan; and

WHEREAS, The Mifflin County Commissioners and on behalf of the Armagh, Brown, Derry and Granville Township Supervisors and Lewistown Borough Council are familiar with the requirements of the program as provided for in the Housing and Community Development Act (HCDA) and the Community Development Block Grant regulations; and

WHEREAS, the Mifflin County Commissioners and on behalf of the Armagh, Brown, Derry and Granville Township Supervisors and Lewistown Borough Council wish to apply for said funds.

NOW, THEREFORE, BE IT RESOLVED by the Mifflin County Commissioners that the FFY 2023 CDBG application is hereby approved for the proposed activities listed below:

BE IT FURTHER RESOLVED, that the Chairman of the Board of Commissioners of Mifflin County is empowered to place his/her signature, on behalf of the governing body, on necessary application forms and affix thereto the official seal of Mifflin County.
